Hope all are enjoying the early days of summer. Your association progresses along, and a number of interesting developments have presented themselves. Grab a cool one, sprawl in your hammock, and read on....

Historical integrity and related matters...Members may recall an earlier mention of Douglas Valentine's THE PHOENIX PROGRAM(Avon Books, 1992), and questions regarding its accuracy, authenticity, etc. PHOENIX dust jacket blurb called it 'A shattering true account of the CIA's bloodiest reign of terror....', which comes as no surprise given author's intent to create a sensationalistic tome. Valentine relied heavily on accounts from four 'former SEALs', Elton Mazione, John Laboon, Eddie Swetz, and Kenneth Van Lesser. All reportedly participated in 'Phoenix' operations. Well, sometimes things aren't as they appear to be. The Military Personnel Records Center has no record of Manzione, while the other three are US Navy vets, though none were SEALs, none served in Việt Nam. Van Lesser didn't enlist until 1977. Member FRANK BROWN noted these and other glaring discrepancies in a review for the Foreign Intelligence Literary Scene, concluding that 'PHOENIX only proves that 'a penny, held close enough to the eye, can blot out the entire universe.'. Happens all the time.

In another instance, several Counterparts/THDNA members were contacted by an author who was ghost-writing the war chronicles of a 'Green Beret' who appeared to have 'done it all', to include several weeks as a POW in

a remote VC camp. Author in question sought a constructive review and invited suggestions. Three of your fellow members touched base, discussed reviewed portions, and smelled a rat, and politely suggested the author check into matters a bit more closely. He did, and... 'I was quite disappointed to find out that the greater portion of statements given to me by Sgt. 'X' have proven to be fabrications of a delusional mind. .... His service MOS in fact, was a supply clerk in Việt Nam. The disappointing thing is that I have been unable to legitimately accomplish my goal of promoting Việt Nam Veterans issues. I feel I have mocked them with the story I began to write, and in my ignorance was influenced by the 'hero' before me. .... Thank you for your time and expertise in reviewing my manuscript.' Perhaps this will keep some rot off highschool library shelves, and tales of collecting ears to verify body counts and every other media cliché. Finally, one member has been invited not to renew his membership for having embellished his bona fides. Oddly enough credentials were valid without creative amplification of same. Invitation was accepted. First time we've had to do this.

SUNGEI BESI REFUGEE CAMP Still no luck in penetrating diplomatic and political fog. Call placed to US delegate to UN produced no results beyond referral to State Dept., which in turn generated referral to United Nations High Commissioner for Refugees. Oddly enough, US UN Ambassador Madeleine Albright is the daughter of a Czech political refugee. This looks like a situation demanding mosquito fog of letters/calls etc. Write your elected leaders. Member Tom Harvey, previously referred to as 'Member X' (prior SITREP) visited Sungei Besi in early May and found Sungei Besi is run much like a prison. Visits are limited to one hour, in an office outside the camp itself. Visitors may not visit the camp itself or meet with anyone except identified friends. Approximately 9,000 people are in Sungei Besi, and those denied refugee status are kept separate from those passing interviews. Tom had just come from VN and feels refugees would be better back home than in Sungei Besi, where many have been in limbo for four years. He added 'The staff I saw seemed cruel and heartless, treating the refugees like dirt. I was more than a little shocked, greatly saddened.' Elsewhere, the 'Việt Nam Journal' (3 issues/year, \$6.00, from: Viet Nam Human Rights Group; P.O. Box 1163; Burlingame, California; 94011-1163), reports fate of 'Nguyễn T. P.', former interpreter for Australian and US units. Accused of 'working for the CIA', Nguyễn T.P. was subjected to torture, imprisonment, solitary confinement, etc. Upon release, 'T.P.' foraged and scrounged out a living (the family farm having been confiscated) until 1990 when he was tipped off that the authorities wanted him again. He fled to Thailand, where his appeal for political refugee status has been denied. The Journal also reports of United Nations High Commissioner of Refugees (UNHCR) complicity in all this, as manifested by UNHCR senior official Christine Mougne's memo advocating cutback in medical services, visitation, education, etc., as a means to raise misery index in camps, thereby encouraging acceptance of forced repatriation. Situation already volatile, with hunger strikes and periodic suicides. 80,000 VN refugees in Thai, Hong Kong, Malaysian, Philippine camps, a good number of whom have credentials similar to 'Nguyễn T.P.'. They were, and are, our Counterparts. Write letters, do something. Situation is not good, not getting better.

### Indochina Chronology

#### Names in the News

Nguyễn Quý An. A South Vietnam war hero caught in a Catch 22 situation of almost unbelievable stupidity on the part of the U.S. Government. An received the USAF Distinguished Flying Cross in 1969 for his daring rescue of four American downed airmen. Later, in battle, he lost both arms. The victorious communists deemed him "unqualified" for re-education camp (because he could not take care of himself). Had he gone to a camp he would have

been eligible to come to the U.S. under the Orderly Departure Program. An did serve 17 months in jail for trying to flee Vietnam but that does not qualify him. Vietnam agrees to release him. Meanwhile he ekes out a living as a gardener and English language teacher. Says U.S. Col. Robert Morrison (Ret.) (whose men An saved): "It is difficult to see our country treating someone like this whom we have decorated for valor." The understatement of the year. ("U.S. Decision Traps Vietnam War Hero: Vietnamese Copter Pilot Who Saved U.S. Lives is Trapped in Homeland," by Ken McLaughlin in *San Jose Mercury News*, March 21).

Contact established w/Ken McLaughlin who has promised follow up information. Article as printed in Indochina Chronology.

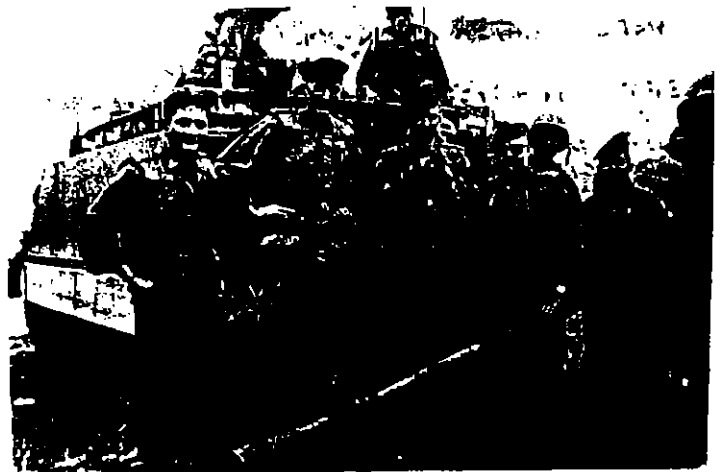
Contact also established with VN Political Detainees Mutual Association, via inquiry as to any political detainees who may have had US Counterparts. This group sent a 7 Feb 93 letter to US Pres. and Congress, requesting consideration be given to 508 former political prisoners now denied refugee status. Response unk. at this time.

Suffice it to say an entire SITREP could be dedicated to detailed documentation on this subject. When will the war be over? Situation demands pressure on elected officials.


Dear Mr. Herberth:

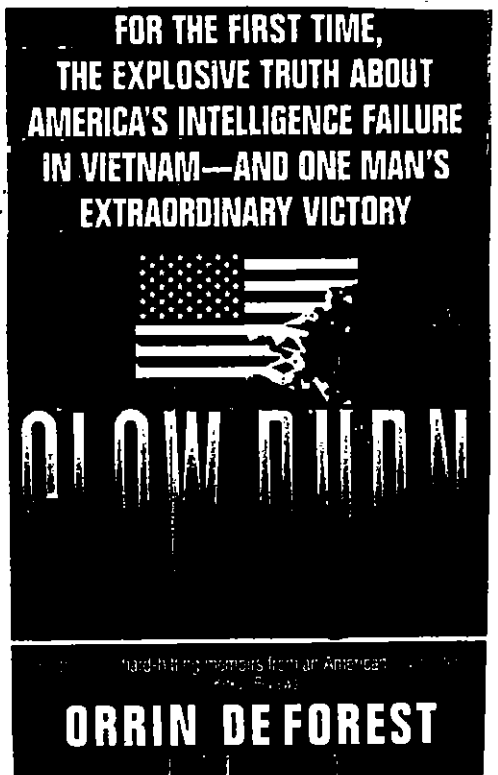
# THE BLACK TIGERS

It has captured the image of the VN Ranger that was seldom reported—as fierce and deadly as any 'military elite' to have graced the battlefields of Indochina. I'm proud to have been a part of it.'. SLOW BURN, by Orrin De Forest. Author, a skilled intel operative, arrived in VN in late 1968, finding inexcusably poor handling of POW data/interrogations, and resultant ignorance of VC structure, organizational dynamics. Like many, De Forrest extended, and extended, consumed by personal commitment to get things done, and done the way they should be. Working with an expanding and craftily assembled agent network, author began running things as they should have been run in 1961, often succeeding in spite of bozo policies/decisions obzing from US Embassy or CIA HQ. Excellent work, concluding with author's embittered departure from VN in 1975, his success and that of his VN Counterparts negated by clumsy execution of flawed policies and absence of a true strategy. SLOW BURN will cause heartburn, and is written w/deep personal conviction.



# A DOVE IN VIETNAM

MIKE McGRADY

WINNER OF THE OVERSEAS PRESS CLUB AWARD FOR  
BEST DAILY NEWSPAPER INTERPRETATION

Out of Print....A DOVE IN VIET NAM, Mike McGrady, 1968. Author, a self-professed dove went to VN in 1967 to see for himself. Much of his book is what would be expected: an indictment, however civil and devoid of radical fulminations, of the war. Many of his complaints are valid and have been echoed by COUNTERPARTS/THĐNA members. Bias notwithstanding, McGrady speaks well of a US Cđ Ván, dedicating one chapter appropriately titled 'Major Priddy's War'. Priddy, a DSA in Phung Hiệp Dist., Phong Dinh Prov., 'did not napalm the houses, burn the towns, shoot livestock or destroy rice crops.' (author's words). McGrady goes on to say 'It is not simple to fight Maj. Priddy's kind of war. It requires patience, skill, imagination and intelligence. It requires bravery of the highest order; it requires flexibility that too often seems lacking in the military mind. It requires-above all-an interest in the people of Việt Nam.....'. McGrady also notes efforts in building clinics, schools, and improving

sanitation, midwife training programs etc., and concludes that while VC presence is formidable in Phung Hiệp, 'the VC are losing the battle'. Eyes thus opened, McGrady backs away from an 'immediate withdrawal' position, but insists we send more advisors who speak VN and will work with the people, as opposed to increments of conventional units, the presence of which-in his view-is overly costly, destructive and counterproductive: 'Major Priddy's victory represents a striking departure from this country's general policy of warfare in VN.' Indeed. Priddy sounds like a guy we should track down.

Periodicals Việt Nam magazine, Aug 93 edition has article 'Heroic Allies', by Harry F. Noyes III (USAF VN Vet), in which authors spares little praise for QLVNCH forces. Citing instances of bravery as well as weaknesses, Noyes makes a key point typically overlooked: QLVNCH experienced much the same growing pains as did the US Revolutionary forces in 1776, and throughout the War for Independence. He also notes that the war began seven years before US line units showed up, and continued five years after they left. Somebody was fighting, and that somebody was RVN forces, who sustained somewhere in the area of 225,000 combat fatalities (at this percentage of population, we would need about fifty 'Walls' to list US KIA). Noyes also takes a few appropriate swipes at news media, and lethal cutbacks in US aid at a time when NVA forces were better equipped than ever.

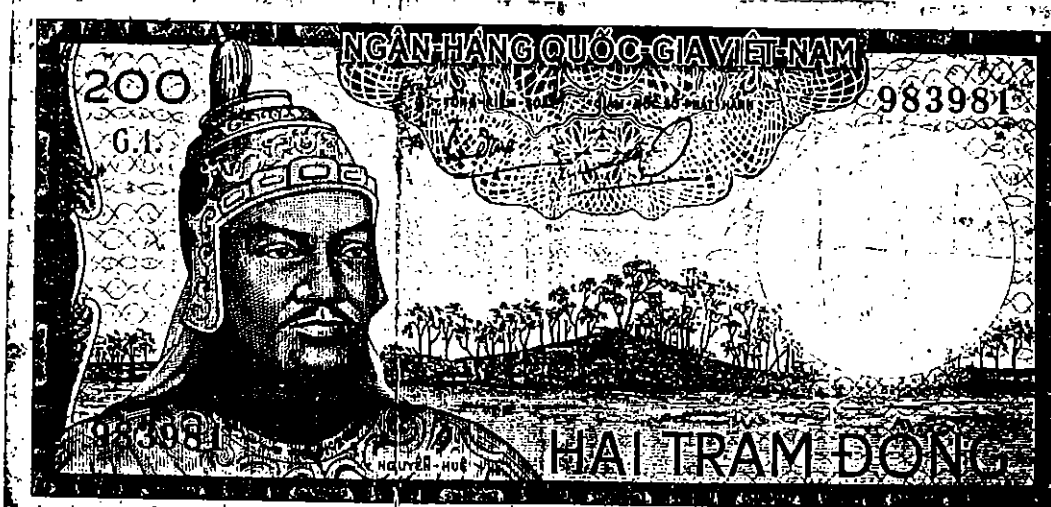

INTERNATIONAL COMMITTEE FOR A FREE VIET NAM Inaugural reception for Eastern Regional Chapter held 27 June 93, in New York City. COUNTER-PARTS/THONA represented by Grant McClure, Roy Russell, Kok Ksor and John Del Vecchio. Additional invitees: Dr. Jane Hamilton-Merritt and Vang Pobzeb of Lao Human Rights Council. Gathering was unique and noteworthy insofar as it did not solely focus on Human Rights Violations in VN, committed against VN people, and instead took a wider perspective, addressing deplorable situations of the Dega and Hmong peoples, as direct result of Hà Nội policies. Prelim reports indicate all went well. The ICFVN is to be congratulated for inviting Kok Ksor to speak on behalf of the Dega, and Dr. Jane Hamilton-Merritt on behalf of the Hmong. Members should be advised that the ICFVN is truly an international organization, having members all over the world, with an impressive membership list of scholars, politicians, professionals of many stripes, and takes no position beyond advocating human, civil and economic individual rights in SE Asia. In related matters, our CO, Grant McClure will accompany Dr. Le Nghia to Việt Nam, and is in-country as you read this. Grant and Dr. Nghia will be meeting with pro-democracy leaders in Việt Nam to gain direct knowledge of present conditions and developments. Grant will no doubt be in contact with some former counterparts, and will try to meet with our sponsored VN orphan in Hà Nội. Detailed trip report will be presented to members.

HIGHLANDS ASSISTANCE PROJECT/DEGA Matters From H.A.P. Liason Officer Mike Little: Kay Reibold's March 93 visit to VN did not result in permission to enter the Highlands, though some progress made in other areas: Officials at Highlands University (Ban Mê Thuôt) accepted terms for English/computer program, and 50% admission rate for Dega students; Well construction begun, and vitamins/clothing provided for Roglai Leprosarium at Suoi Tien (visit denied in '92); materials for well construction provided to construct 3 wells for Leprosarium in Kontum; feasibility study for proposed silkworm project for Chru villagers in Lâm Đông (home of Han Cao Dung, Dega brought to US for back surgery; Dung can now walk without a cane); meetings with Dega families to discuss reunification with families and ODP matters; leprosy sandal program in Qui Nhon expanded; and contract signed with Sài Gòn construction firm to build leprosarium in Cheo Reo. Members Kok Ksor and Roy Russell travel to Geneva to speak before UN Working Group on Indigenous Populations, 19 Jul-30 Jul. As reported by Roy: 'With the Montagnard issue thrust in full world view by recent events COUNTERPARTS/THDNA members are working to gain UN recognition for the Dega as an Indigenous People, which would qualify them for various Human Rights protection efforts under UN auspices. Grant McClure, Mike Little and Roy Russell have teamed up and prepared a formal funding application to enable Kok to attend the Geneva Human Rights workshop. This application documents Dega history and qualifies Kok Ksor and the Montagnard Foundation to represent Montagnards still residing in SE Asia.'

Donations to help fund this trip, cost of which is entirely borne by attendees themselves, are welcome. Send to Mike (address above), w/ checks to: Montagnard Foundation. Ken Swain also going to Geneva.

Any success in this venture will open doors for other Human Rights inquiries in VN, Laos, Cambodia.

A worthy cause. Do what you can to help. Final note, member Nay Rong's son has still not been permitted to leave VN, having been bluntly told that his family is an 'enemy of the people' or some such thing. Extreme case of malignant sour grapes at work here.

MEMORABLE EXPERIENCE Member Don Souder recalls... 'As team medic (Tm 98) in Biên Hòa, '68, I was on a MEDCAP outside of Dĩ An. One patient had a bad cough, and I gave him some small pills for the ailment. Priding myself on learning Việt Nameese, I gave him instructions to take one pill three times a day. He stared at the pill vial questioningly, and I asked him what was wrong. He paused, then asked how to cut the tiny 4 mg pill into three pieces. When I'd told him to take one pill, three times a day, that's exactly what he was going to do. Needless to say, I decided I had better learn a lot more about the language and the people.'

Don has another story for next edition, along w/mini bio of Don's VN tours. Thx for sharing this one Don, and providing yet another example of the difficulties in know<sup>ing</sup> some of a language, while not being 100% fluent.

MEMBER PROFILE: I came out of the Tennessee hills as a teenager and went to Korea, serving two tours. After that, I went back to the U.S. to finish college and ended up in Hawaii, where I work as a writer. Along the way I became an Army Reserve officer, resigning when I couldn't get into Special Forces because of a quota system. I accepted a Navy Reserve commission and this led to me being assigned to the Junk Force in Vietnam, going there first in 1964.

The first day in country was memorable: The Navy Captain I reported to gave me a direct order to shave my beard and I as directly refused; a few hours later I was drinking "33" on the beach at Vung Tau and thinking I'd gone to paradise instead of war; a few hours after that I found myself alongside COUNTERPARTS member Jim Vincent in the rain, darkness and mud of our compound, returning fire on Viet Cong who were doing their damndest to eradicate our base. When I finally closed my eyes that night I was wondering if my entire time in Vietnam would be as interesting. It was.

Prior to Vietnam I had spent considerable time in Asia, in a job that took me into most places between California and India. I loved Asia, and fell in love quickly with Vietnam. I suspected that I would learn more than I would teach, and this was the case. In subsequent assignments, mostly in the Delta, I became increasingly frustrated, angry and depressed at the U.S. government's policies. I knew that if they let the Captains run the war instead of the politicians, we could win it. In civilian status between my assignments in Vietnam, I wrote about the Hmongs and the Khmers and others. I'd been illegally in both Laos and Cambodia and gotten good looks at some of the situations that my COUNTERPARTS colleagues know better than I. In military status I kept going back to RVN. It was heartbreaking to see a nation of such fine people, by and large, drifting inexorably toward chaos. I think we all saw it coming, but the U.S. government seemed paralyzed.

I was in Hawaii when the end came. I remember telling somebody that the Communists would screw up the country for the next 30 years, and I haven't changed my mind...unless, of course, the U.S. conveniently forgets the war and the MIAs and POWs and the atrocities and broken promises and the illogic of an unworkable economic and political system...unless the U.S. forgets all that and rushes into a too-soon recognition of and aid to the Socialist Republic of Vietnam. In which case, we will truly have lost.

I'm not a joiner, but I treasure my membership in COUNTERPARTS/THDNA because I feel I am among kindred spirits, and especially among people who know much of the nitty-gritty of IndoChina, and people who respect the fine qualities of the Asian people. After I came out of Vietnam for the last time I refused to talk about the country or the war with anyone who hadn't been there. This has evolved into my refusal to talk about it with anyone who hadn't been in combat while there. I still think this is a good policy. But I am pleased to be among people in COUNTERPARTS who know what they're talking about. I'm proud to hold Life Membership card #001.

--We're glad you're on board Scott, and were instrumental in getting this group off the ground. Scott is author of THE COASTS OF WAR(1966), novel of junk fleet C8 Vans in the Delta, SONG OF THE WOLF, and co-authored WRAPPED IN THE WIND'S SHAWL, one of the first books describing fate and conditions of the 'Boat People'.

Excerpted from 'CAP NEWS': Connie Menefee, Associate Member of both CUVA & COUNTERPARTS/THDNA, compiled following information: CAP units averaged 11 USMC and 24-27 PFs, operating in a village area of approx 4 square Km, w/3,500 villagers. In Jan 68, CAPs were less than 3% of US forces in I Corps, and accounted for 43% of small unit En KIAs. Less than 1.5% of USMC were in CAPs. Overall CAPs accounted for 7.6% of VC/NVA casualties, while sustaining 3.2% of USMC casualties. 1969 was peak year, w/114 platoons, made up of 1,710 USMC, 119 USN Corpsmen. 75% of patrols conducted at night. Estimated annual cost to run a CAP: \$172,000.00. If CAPs had been used in contested hamlets (base of 10,400, many of which were not in bona fide 'bad' areas), ten year cost of war would be \$18.0 billion, contrasted w/\$140.0 Bn actual at end '73. Of paramount importance, VN village people would have known US types on daily basis, rather than having been merely exposed to large unit sweeps and such. Thx to Connie for compiling this information.

And, had we had more CAP type units, more vets would feel like Richard Lust, whose letter in CAP News reads...' For years I've been telling people what kind of unit I was in and even many VN Vets look at me like I'm nuts. .... I hated being in a line company...when I let it be known that I would extend to get to a CAC unit everybody thought I was crazy. (After) raising holy hell...I was sent to a CAP near Chu Lai. .. I was with them for about 6 or 7 months. When I left Việt Nam I actually cried. I left some great people behind.'

Contrast that opinion with what US non-vets, and some vets, might infer from watching 'Platoon' and 'Apocalypse Now'.

CUVA will soon be handling orders for A PERSONAL WAR IN VIỆT NAM, by Robert Flynn, the true story of USMC-PF units in southern Quảng Nam Prov., near LZ Baldy. Check w/Tom Harvey for more info.

POW/MIA matters... Controversy continues over Soviet document alleging more US POWs than Hà Nội admits to. COUNTERPARTS/THDNA has received copy, in both Russian and English, and it does state numbers reported. No hard confirmation or denial available, like much of information coming to surface. Things get bitter and lawsuits are in the air, with several POW/MIA activists being sued by those holding contrary opinions. Odds are good for continued acrimony and mutual accusations.

POW/MIA(cont.) .... US delegation meets w/Hà Nội officials to begin joint archival research effort, delving into Hà Nội documents and viewing film footage. Sen. John Kerry optimistic about ability to digest more info. Sen. John McCain blows fuse when Hà Nội spokesman speaks of 'humane treatment' of US POWs: 'Come on Mr. Dich, stop saying that. It is not true. I never got any magazines to read. We were not treated humanely. Let's get on to the next subject. This is not the truth.' Also in attendance: Sen.s John Glenn, and Reps. Pete Peterson(former POW), Lane Evans, Dana Rohrabacker, and leaders from other veterans groups. A month later, Sen. Bob Smith and Robert Garwood, the latter being either a former POW or a collaborator, return to VN in search of evidence supporting Garwood's assertion that he saw other POWs after 1973(Garwood returned to US in '79). Ho Xuan Dich, director of Hà Nội's POW office, stepped in again, suggesting Garwood was 'an officer in the Việt Nameese Army at the time'. Garwood erupted, shoving finger in Dich's face and saying 'You are my enemy. I'm not your friend. I was never your friend.' Mr. Dich will no doubt be scheduled for cultural sensitivity seminars in preparation for his future dealings with Americans.

Garwood/Smith mission returns with no concrete results, though Sen. Smith concluded US quite guilty of 'sloppy research' in compiling and acting upon POW/MIA reports. Later, Sen. Smith addressed annual meeting of National League of Families, stating that Hà Nội's position has hardened, and he had been told that US would get 'additional information when we(Hà Nội) are ready.', implying they'll be 'ready' when US embargo is lifted. Presidential adviser Samuel Berger also addressed the League, indicating Clinton will not lift embargo and/or open diplomatic relations until he is satisfied Hà Nội has done everything possible to resolve the issue. Meanwhile, Clinton lifted US opposition to Hà Nội access to World Bank development funds. League Ex. Director Ann Mills Griffiths not happy with that, viewing it as 'most disastrous decision in years', frittering away US bargaining position. Finally, US officials turn over part of 'huge collection' of captured NVA documents to assist Hà Nội researchers. We shall see.....

And,....Adm. James Stockdale, former POW is honorary chairman of the POW Memorial Museum, now under construction in Andersonville, Georgia(site of an infamous Confederate POW camp during Civil War, where 13,000 of 45,000 Union POWs died of malnutrition, starvation, disease). Museum is to preserve memory and history of all US POWs, from all wars. More info from: Anderson POW Museum; Andersonville National Historical Site; Andersonville, Georgia; 31711.

Post election sour grapes compelled one of Sihanouk's sons (w/Hun Sen) to threaten secession of eastern provinces, long the stomping grounds of Hà Nội faction of Khmer Rouge. Elections not without bloodshed. KRs fired on UN contingents. UN's 'Strategic Investigation Team' scours countryside to ID and deport ethnic VN; ID/screening criteria reportedly cursory and operating under expeditious guidelines. ....

LAOTIAN UPDATE Not much new, and nothing good. Forced repatriation continues apace. Thai govt. plans to close out all border refugee camps by 1994. Food supplies cut off to anyone refusing to register for repatriation. Martin Brennan, US Embassy, Bangkok official in charge of refugee matters, meets w/Hmong in US, stating US will help those who do not want to return to Laos, and who are not eligible to resettle US, return safely to Laos. No explanation as to how their rights would be protected. Members are reminded of House Bill H.R. 3552 and Senate Bill S.1970, both designed to expedite naturalization of Hmong who served, essentially in a joint US-Hmong command, in Special Guerrilla Units. SGUs were responsible for saving lives of US pilots shot down in hostile territory, succeeding on more than a few occasions. .... Press run of TRAGIC MOUNTAINS reportedly halted at 2,000 copies, reflecting less than intense US reading public interest in the subject, and corresponding preference for now familiar escapist literary swill and Donahue-Oprah 'exposes'. This book should be in every college and public library in this country. It isn't, and even if it were, few would read it. Had US or Royal Lao Govt.s implemented these forced relocation policies 25 years ago, a deluge of protest would have occurred. Makes you wonder.

Wondering some more..... In 1964, Thích Quang Duc immolated himself, protesting religious persecution; photos of his flaming body, in the sublime lotus position, were on front pages of newspapers worldwide.

In July, 1975, after the 'end of the war', Buddhist monks in Cần Thơ immolated themselves, protesting religious persecution. CBS was not there to film it; world response conspicuous in its absence.

In April, 1993, Buddhist elder Pham Gia Binh immolated himself, protesting religious persecution of Buddhists in VN; his Ellington, Connecticut associates were arrested.

In May, 1993, Buddhist monk Ho Quang Da, protesting religious persecution of Buddhists, immolated himself at Huế's historic Linh Mụ Pagoda. Photos of his flaming body did not appear on front pages of world papers.

Israel and VN establish diplomatic relations, ....VN hosted a surfing tour, w/US kids showing VN kids intricacies of surfing; international surfing competition scheduled for 4-11 Oct., at China Beach; beach volleyball tournament scheduled for Aug at Sam Son, 105 Mi. S. of Hà Nội ..... VN stock exchange planned to open by year's end. .... Hà Nội directs 10,000 state-controlled businesses to privatize.. rice exports up 30% over last year, while 4 million children are reported to suffer from malnutrition (can't have your export receipts and eat 'em too), Hà Nội MBA students play 'Monopoly' to learn about free markets... S. Korea firm and VN agency plan fibre optics joint venture ...Bank of America opens branch in Hà Nội..

MEMBERS SPEAK 'I oppose in strongest possible terms Counterparts decision to formally oppose normalization of relations w/Viet Nam. My conviction was solidified during a 1989 visit to VN to help build a medical clinic, when effects of US-orchestrated isolation was visible. Ordinary people suffer, especially-ironically enough-former QLVNCH allies left behind, and who are now the lowest of the low in terms of access to VN's scant social services, such as schools. Counterparts/THDNA has a very valid concern with VN's Human Rights record ...nevertheless I believe that improvement of those abuses would be effected through normalization, and resulting exposure that would entail. Counterparts has taken a stand which I know to be wrong precisely because I have seen ramifications of such a stance, first hand, in Việt Nam.' -Mike Peterson

Ed.-Mike is correct. COUNTERPARTS/THDNA, as an organization, is not to take a position on normalization or other political matters, human rights violations excepted. We are proscribed from this by our own by-laws as well as our now existing tax-exempt, non-profit status (profuse ~~tax~~ to Joe Cagney). While most members probably oppose normalization at this time, and have sincere reasons for their opinions, the fact remains that all members are free to make their own decision on this, whereas COUNTERPARTS/THDNA restricts itself to putting facts on the table. As long as we do this, and as long as we recognize the inherent logic and merits of conflicting opinions, we will do fine. Counterparts/THDNA will continue to advocate restoration of civil rights to former comrades still in-country, as well as an honest resolution of POW/MIA matters, irrespective of the normalization question. We are big people now, and need not squabble over conflicting, yet sincere, opinions. Thx to Mike for calling this out.

'I will feel happy and honored to join COUNTERPARTS/TƯỜNG HỮU ĐỒNG NAM Á. I was Deputy Prime Minister in charge of Social Welfare, Refugee Relief and Resettlement, Land Development and Hamlet Building. Ray Fontaine worked closely with me for almost 6 years, and we visited practically every district and village in the Mekong Delta, MR III, the coastal regions of Regions I and II, as well as the Highland forests. We were many times shot at by the Vietcongs, and had other accidents but, thanks to God, we always emerged unscathed. Ray came to know me and the VN people quite well, and I came to know the dedicated, brave and kind-hearted GIs whom I met in the provinces. When I visited the US during the war, I was shocked by the unfair way US soldiers were treated by the media and public opinion, and I took to their defense with vigor and consistency. .... I hope that our cooperation will grow in coming months and years. US VN War Veterans can help influence White House and Congress to adopt policies promoting freedom and democracy. This is the best way to pay tribute to US and VN and other allies who fought and died for freedom. With warmest regards and a hearty hello to all our friends in COUNTERPARTS/THDNA.'

We lied. There's more, courtesy of Col. Noboru Masuoka (USAF, Ret.), who is leading effort to get Maj. Nguyen Quy An to US (see page 3, this SITREP). Dcoments provided indicate Maj. An flew SOG missions for 4½ years prior to being shot down and losing his arms.

Full documentation of Maj. An's DFC citation (downgraded from Silver Star recommendation), includes statement at right, w/similar statements from two other US on mission. Two, including Robt. Stratiff, have been located by Ben Myers and have connected w/ Col. Masuoka, who reports of their anger at An's fate, and obtus screening procedures of US refugee screeners.


Letters to officials have produced zero results, and responses having patronizing text of mass mailing for vinyl siding.

By virtue of SOG service, Maj. An qualifies for COUNTERPARTS/THDNA membership. By virtue of his actions, he deserves far better treatment from US govt. Members are encouraged to write letters on Maj. In another Locator matter, a UN High Commissioner of Refugees representative had long been seeking anyone who could verify bona fides of Dang Tran Nghia, former interpreter for PRUs, and named three individuals (US type) with whom Mr. Nghia served. Ben Myers went to work, and found one, relaying info to UNHCR rep and presumably clearing the way for Nghia's emigration to US. Neither Nghia's service w/PRUs nor Maj. An's receipt of US award for valor enhances the social standing of either of the individuals in VN. We may have problems here and there, but we're still getting things done.

On 17 January 1969, I was flying as pilot on an unarmed helicopter of the 189th AHC. We were operating out of Dak To and working with the "King Bee" helicopters of VNAF. Late in the afternoon we were scrambled to insert a platoon into a classified area west of Dak To. CPT Nguyen Quy An was "King Bee Lead." He and his 2 helicopters were to insert the bulk of the platoon while CPT Liner and myself were to insert the remaining 6 men. CPT An and his crew, LT Vu Tung, pilot, and WO Nguyen Quang Hien, crewchief, lead the flight into the LZ. As they approached the lip of the bomb crater clearing they came under fire and notified the rest of the flight as to the direction of fire. We couldn't see the enemy fire but we were able to spot the positions by his crewchiefs return fire. After the "King Bees" made their departure we were on short final to the LZ. We made the insertion without incident and began to hover out. We were informed not to break over the dirt road adjacent to the LZ because of recent enemy vehicular traffic. As we broke left we were struck by what was later determined to be a 37mm round. It struck our fuel cell and we caught fire. It seemed like only a split-second later that I saw a "King Bee" helicopter off our right side. It was CPT An who had left his orbit high above and (as we later learned) spotting our burning "slick," had entered a high-speed dive to catch up with us. As we were frantically searching for a forced landing area CPT An radioed us that there was a clearing to our northwest and we should try to make it. Meanwhile he was vectoring the gunships toward us. As we approached the proposed LZ CPT An was right next to us. He saw (as did we) that the stumps and trees would not permit even a reasonably safe landing. He then maneuvered his ship so as to prevent our landing and at the same time told us that there might be a better area over the ridgeline in the valley. We were getting very low on fuel and the hydraulic lines had burst. As CPT An said, we did find a better LZ in the valley. As we were breaking left to land he was breaking right and shooting a parallel approach. It was great seeing him there, as we were now so low on fuel (200 lbs) that another abort was impossible. We landed and left our burning aircraft, taking the radios and crew served weapons with us. As we thrashed our way through the 15 foot tall elephant grass, CPT An's crewchief, WO Hien was making his way toward us. He helped us all aboard and only after we were all safe did CPT An and LT Tung take off. These gallant men saved our lives. If it were not for their prompt and heroic actions I feel sure that we could not have made it.

I highly recommend CPT An, LT Tung and WO Hien for American Valor awards.
