Following submitted by member Bobby Jackson:

On the weekend of 23-24 July, before our Killen reunion, a celebration was held honoring the 34th Anniversary of the RVN Rangers, better known as Biet Động Quân. Hosted in Houston by the Việt Namese Ranger Assn. of Texas, the weekend included social events and many informal sessions. The commemoration was attended by more than 300 RVN Rangers and their families. I had the priviledge of attending with two other BDQ Cổ Vâns, Roy Lombardo (41st Rgr Bn and 4th Rgr Group, 1967-1968) and Mike Martin (32nd and 44th Rgr Bns, 1965-1966). Mike coatuhored THE BLACK TIGERS, an excellent historical account of the BDQ. The honored guest and keynote speker was General DÖ Kế Giai, the last RVN Rgr Commander, only recently released by the communists after 17 years in the labor camps.

BDQ Commemoration(cont.)

I was fortunate and extremely pleased to meet several RVN BDQ comrades with whom I served in 1967. As a representative of COUNTERPARTS/TUONG HUU ĐÔNG NAM Á, and the US Army Ranger Assn., I was honored to be in the presence of the elite and dedicated Biệt Động Quân. Needless to say, the event was an extremely rewarding experience.

An excellent commemorative publication, ĐẶC SAN MŨ NÂU, was passed out at the event, containing many stories and anecdotes of BDQ history and accomplishments, and a short piece by member Mike Martin. Stories included accounts of TD 92(92nd Bn), who withstood a 510 day siege at Tông Lê Chân(1972-1974), last battle of TD 58(58th Bn), TD 52 exploits, TD 30 ops in Mô Vet/Parrot's Beak, and sobering accounts of 'life' in the infamous Trai Cai Tao/POW camps. Of additional interest to COUNTERPARTS/THENA members is a short piece on our Members in to COUNTERPARTS/THDNA members is a short piece on our Member in Memoriam, Dai Ta/Col. Ho Ngoc Can, BDQ and Chudng Thien Prov. Chief in 1975. Can refused to surrender, yet was captured shortly after the final capitulation, uttering these decidely undiplomatic words:

> 'Tổi không đầu hàng, các ông cứ bắn tôi đi. Nhưng trước khi bắn, tôi xin được mặc quân phục và chào lá quốc kỳ của tôi lan sau cung.'

(I do not surrender, you can go ahead and shoot me. Before you shoot, I ask to wear my uniform and salute my national flag one final time.)

Upon receiving his death sentence before a tribunal in Can Tho. Can told his captors:

> Dừng bịt mắt tôi. Hấy để tôi được nhin đồng bào tôi trước khi chêt.'

(Don't blindfold me. Let me see my people before I die.)



Dai úy Reap was seriously WIA by B-40 in 1969, received treatment in US hospital, and returned to command the 188th. MEMBER PROFILEFrank Brown... 'I was born and raised in a small town in the Delaware Valley. After high school I briefly attended college, then worked as a reporter for local newspapers, before joining the Navy. Never had cause to regret that, and 28 years later I'm still steaming at flank speed.

War is said to hold a romantic attraction for young men, and I was no exception, wanting to get to Viêt Nam in the worst way, a dream which was realized twice, through a device suphemistically known as the 'Master Viêt Nam Volunteer List'.

My first tour was in the 7 Mountains region of Châu Đốc, in the western reaches of the Delta, where I served as assistant district team medic in Tri Tôn Dist., 1969-1970. It was a scene direct from Kipling: mud forts, fierce ethnic tribesmen, remote temple complexes surrounded by nipa palms, and small hamlets w/exotic names like Krang Preas, Thnot Chrom, Obalay, etc. Much of my work was with a squad of Kit Carson Scouts, all ex-VC of Khmer ancenstry. Our district had 8 RF companies, 20 PF platoons, and about 4,000 PSDF, the latter utterly lacking in weapons and training but not in bravery,; and of course, our Scouts. We dealt w/three NVA regiments(18-B, 95-A, 101-D), plus remnants of

the C-804 VC local force company, led by the notorious Chau Kem. We were outnumbered, outguined, and always short of supplies---and never gave an inch. We took what the VC/NVA threw at us, and gave it back. Many memories stand out in my mind. The time we almost shot Chau Le by mistake because, in his eagerness to close with the enemy during a night ambush and pursuit, he went well beyond our skirmish line. Or the time Chau Got saved my butt by pushing me out of the line of impending AK fire during a daylight foray into the abandoned hamlet of Kok Khvao. Or the hideously wounded Cambodian kid Greg Horan and I worked on for hours to keep alive, only to have him expire 10 minutes after a medevac chopper picked him up.

My second tour, in the Da Nang/Hôi An area, began in fall of '71. When the Easter Offensive erupted, I was sent to Quang Tri, w/the 1st Air-Naval Gunfire Liaison Company, where were directly involved w/the 'BAT-21' rescue. Far too little has been written about this offensive, especially about the role played by RVN Marines, and the performance of PF and RF troops along the Thach Han River in the opening days.

In spring 1975, I was attached to the 3rd Marine Air Wing, El Toro, California, when the end came in Việt Nam. Soon, I and an interpretor were boarding packed-to-gills aircraft, performing medical screenings on refugees. I remember the widespread media speculation of Việt Namese and Khmer refugees arriving w/gold bars and suitcases full of dollars. I saw none of that. Absolutely none. Most of the folks I saw were lucky to get out with the clothes on their backs; some carried small overnight bags. Many family members were dispersed between Guam, other refugee sites, or even still in Việt Nam.

Despite all the fiction and fabrications about Viet Nam, I believe the tide is turning-albeit slowly-but nonetheless turning. This is due in large part to Viet Nam veterans who have refused to toe the politically correct line. Veteran authors like John Del Vecchio, 'Jug' Burkett, Peter Scott, Malcolm McConnell, and a host of others. Men of principle committed to telling the truth about Viet Nam, and America's role there. In addition, as a charter member of COUNTERPARTS/TUONG HOU ĐÔNG NAM Á, I can truthfully say I've never felt more 'at home' in any other group, and am quite happy to be in the company of those who fully comprehend what Viet Nam meant, and means, to me.'

PHILIPPINES UPDATE: As reported last SITREP, powers that be have decided to close the doors on screening process for refugees in Philippine, Malaysian, and Hong Kong refugee camps. This, despite ample testimony from former UN refugee workers, Father Bob Crawford(a priest in Philippine camps), and refugees themselves that the screening process is fraudulent, poorly managed, and not the least bit concerned with its stated objectives. US govt. pays UN to run process, UN hires contract interviewers, who know nothing of VN/conditions there, and interviewers subsequently both the job(a seven minute interview determines nothing) and/or engage in extortion, exacting bribes in exchange for political refugee status. Complaints to US Dept. of

elicit response that entire matter is a 'UN problem' conveniently overlooking fact that US pays for process, and pays again for those sent back to VN, or Laos. 'Inquiries' go no further than questioning those in the system, rather than those confronted with it. One need only consider the case of Maj. Nguyen Quy An, awarded a DFC for saving 4 US lives in Laos, later a double amputee in another combat action. Good enough to come to US? US Dept. of State said no, as did INS. Maj. An could not have made it here following the official process, and, with ample documentation in hand, was only reprieved by the noble and tenacious efforts of Col. Noboru Masuoka(USAF, Ret), and then only as a one year parolee. He may still be sent back in Jan 95.

If Maj. An's story is any indication, and there is good reason to believe it is, than refugees presently in the camps will be sent back, regardless of their legitimate claims for political refugee status, and because of present policy which has specific objective to accomplish just this. US UN Delegatem Madeleine Albright complicit in process, saying UN screening procedures are just fine, ignoring evidence to the contrary.

In sum, the entire process is a case of cosmetic political expediency, with US leadership(sic) casting aside the ample diplomatic and financial leverage which can be quickly and easily applied against UN bumbling and malfeasance. One suspects a hidden desire to sweep this all under the carpet and get on with the business of selling hamburgers and soft drinks in VN. Presently, there is one group doing its best to shed light on odious policies and injustices they produce: The Boat People S.O.S. Committee (P.O. Box 2652; Merrifield, Virginia; 22116. Landline: 703 204-2662). Dr. Nguyen Dinh Thang, Executive Director, is leading a delegation to Capitol Hill for three days, 19-21 September, attempting to generate some support and force an examination of a highly flawed screening process. The Veterans of the Viet Nam War, Inc. (not VVA) is lending full support, and their Region 6(NW US) director, Nicholas Rock(1916 Pike Pl., Suite 12-616; Seattle, Washington; 98101-1056. 206 220-7905) has been lending energetic support, absorbing considerable copying/postage expenses to get the word out. Dr. Thang needs all the help he can get. Members Mike Martin and Mike Little and Kok Ksor, have been contacted and requested to notify the Society of VN Rangers and Montagnard Foundation respectively (one of Dr. Thang's priority cases is Lam A Lu, a Montagnard Protestant clergyman held in Hong Kong camps). The Saigon Mission Association, whom Father Crawford initially contacted, is also making an effort. VN Vet, author, former Sec. Navy, who has previously spoken out on this issue, has also been contacted. Our membership needs to pitch in with letters to elected officials, US State Dept., and US delegate to UN.

Do NOT simply register a complaint, as the answer will come back, 4 months later: 'We looked into it, everything is OK'(using 387 words). Instead, request an inquiry in which refugees themselves are interviewed, not simply the functionairies and bean-counters in charge of the program. Cite information provided by Boat People S.O.S. Committee which clearly establishes fraud, extortion and malfeasance in the screening process. Do NOT bother asking why US govt. resettled 4,000 Iraqui POWs in US, while letting former allies wallow in oblivion; you'll get same apoplectic response one gets when throwing Holy Water on a vampire. The truth hurts. So, grab pen, paper, word processor, etc., and go to town, as there's still hope. A Federal Court forced the US State Dept to comply w/its own guidelines in screening Hong Kong refugees,

(Thx to efforts of Boat People S.O.S. Committee), so there's obviously a break in State's perimeter of verbal/rhetorical tanglefoot and concertina. Your letter need not be long, yet should clearly state that available evidence does NOT support official State Dept. statements. As is always the case, the Boat People S.O.S. Committee could use donations to cover their mailing/photocopying/admin expenses, and would also appreciate copies of letters sent to elected officials, or bureaucrats.

DO SOMETHING

In a related case, members will recall the cases of Nguyen Tan Tri and Tran Quang Liem, naturalized US citizens who arrested and detained at an official economic development conference held in Saigon last December. A letter sent to Sen. John McCain, among others. McCain answered with promise to query State Dept. Months later, State came back and said they 'deplored' the situation(which means you need not do anything about it but wish to appear as if you wanted to), and had advised Ha Nội that no liaison or interest office would be opened until US citizens, held in VN jails, were advised of the charges on which they were held, and US officials were allowed to meet with these individuals. One week after this response. US officials announced agreement w/Ha Moi to open diplomatic missions in each other's capital. Tran Quang Liem and Nguyen Tan Tri remain in jail. As the old VN saying goes, 'Noi khac, lam khac', or 'say one thing, do something else'.

What makes this all the more repulsive is simple fact that US has

What makes this all the more repulsive is simple fact that US has ample diplomatic leverage vis-a-vis Ha Noi, and has failed to use it to support Human Rights causes the present administration claims to hold dear, mocking the old adage 'You are what you do, not what you say'.

Hung had been sent other letters, in VN, from COUNTERPARTS/THDNA members, generated no response, perhaps because he is no longer living in an orphanage assisted by the Pearl Puck Foundation, to whom our donations were sent. There is almost universal agreement that we can do more good by supporting Tran Van Ca's Việt Nam Assistance to the Handicapped program, prividing prosthetic devices/wheelchairs to former RVN personnel, as well as the Highlands Assistance Program, which brings medical, educational and economic programs to the Highland People. We've broughtom. Hung through most of his teen years and are no longer involved with Pearl Buck Foundation, whose beneficial programs enjoy much more funding and support than the two agencies cited above.



Box 17064; Spartanburg, South Carolina; 29301): Hydroelectric dams, and impoundments resulting from same, have been dislocating Dega people in the past 15 years. The Dega realize that change is inevitable, yet a recent proposed project, the Jrai Ly River dam, causes great concern due to the magnitude of consequences. Its construction awaits international funding.Decade of Indigenous People, a UN program, begins in 1995, addressing destruction of indigenous traditional populations at the hand of economic 'progress'. UN will be closely monitoring situation worldwide, and developing programs to ameliorate adverse impact of culture collisions.....The Montagnard Foundation petitions for UN NGO(Non-Governmental Organization) status, expecting favorable response. ... Member Kok Ksor has been advised the White House may be willing to include his contributions in future foreigh policy briefings, or so anys White House staffer, Doris Matsui, US Information Agency extends same invitation. Thx to Longhouse editors for nice writeup on our Killeen reunion. Article discussed our demand for historical integrity, concern for human rights, and efforts to reunite old friends and comrades. Much appreciated.

POW/MIA Update 30th joint US/Hanoi site search began in late June, with immediate objective of examining 23 crash sites, and cases of 45 other MIAS. Later, Hanoi signalled a willingness to do more to resolve cases, in return for diplomatic recognition and trade privileges. Somewhere, somehow, the unconditional aspects of POW/MIA search and resolution has apparently slipped between the cracks. Hanoi told visiting US delegation it would set up its own team to search documents and archives which might shed

light on the matter. No word as to how this team's efforts might be monitored. Release of POW photos, some depicting-grim portrayals of US personnel KIA, causes an uproar, with some activits claiming US Govt. has concealed info; Govt. responds its objective was to preserve privacy and dignity of families and US KIAs. Wall Street Journal correspondent Barry Wain writes convincing article alleging Hanoi has been warehousing remains, and releasing them at politically opportune moments, and at sufficient pace to keep US negotiators interested. Wain supports his argument by stating 65% of 287 repatriated remains show distinct signs of having been in storage: minimal bone-mass loss, commingling w/remains of others lost in different areas, and detectable preservative coatings. Wain further contends search teams excavating crash sites will not and cannot solve the entire problem, and that only Hanoi's full cooperation will bring resolution. The 5th joint team search began in late August, producing possible remains of a US Marine who died in captivity in Quang Ngãi. LTC Melvin Richmond Jr., head of US MIA office in Ha Nĝi, expresses his hope that significant progress is being made. Sept 9+ issue of 'Popular Mechanics' has article on POW/MIA search, focusing exclusively on crash site investigation and forensic procedures used to confirm ID of located remains.

POW/MIA Postage Stamp Contest: Though repeated calls for a second FOW/MIA commemorative stamp have been rejected, efforts continue to influence decision makers to change their minds. LTC Robert F. Sawallesh. USA, ret, is sponsoring a contest to select a new stamp, which will be forwarded to the Citizens' Stamp Advisory Committee in DC. Rules: 1.Propose a POW/MIA theme/subject, presumably w/rough sketch; 2.Explain why POW/MIA theme should be honored on a stamp, in 50 words or less; 3.Include sketch/drawing(cleaner the better); 4.Send entries to:

MEMBERSHIP REPORT

The active membership of COUNTERPARTS stands at 332 as of 25 July 1994. This includes 40 Life members.

The membership has increased by 113 Annual Members and eight Life Members since the last Reunion. This increase is due primarily to two factors: The story in the Retired Officers Association Magazine and the "beating the bushes" efforts by Ben Myers and JC Fischer.

CONGRESSIONAL HEARING ON VIETNAMESE BOAT PEOPLE

Congressman Benjamin Gilman (R-NY), soon to be Chairman of the House Committee on International Relations, is considering the possibility of holding a Congressional Hearing on Vietnamese boat people. The hearing could be as early as February, 95. As the issue of Vietnamese boat people will have to compete with other issues for a slot in the Committee's hearings schedule, we need to show to the Committee that there are many interested parties. This can be achieved with the following steps.

- 1. Write to Congressman Benjamin A. Gilman
- to express concerns about flawed screening, which has caused a large number of genuine refligees to be screened out and to face deportation to Vietnam,
- to call on Gilman to advise Department of State against ferced repatriation,
- to call on Gilman to hold a Congressional hearing, and
- to suggest that his Committee sends a delegation to the camps.

Notes:

- A sample letter is enclosed. You may want to make some modifications to this letter to make it original.
- Several organizations may choose to co-sign one letter instead of each writing its own letter.
- Please remember to send a copy of your correspondence to Boat People S.O.S. for future reference.

II. Mobilize Members of Congress and dignitaries to voice their support for a hearing and a delegation.

Dear Congressman Gilman:

We write to request your leadership in resolving the Vietnamese boat people crisis in Southeast Asia and Hong Kong. Without a strong intervention from you, the situation will only get worse and we fear that more violence and losses of lives will result.

In 1989, the United States signed the Comprehensive Plan of Action (CPA) and has since spent 150 million dollars on its implementation. Regrettably, screening—the key provision of the CPA—is seriously flawed, affecting the integrity of the entire CPA. Designed to sort out refugees from other asylum seekers for protection, the serious flaws in screening have caused many genuine refugees to be denied of refugee status. We are aware of many such cases. There are many troubling reports with ample of evidences of widespread corruption in screening. Local screening officers and several locally hired UNHCR lawyers are reported to have demanded sex and money in exchange for refugee status.

We have also received credible reports that regionwide forced repatriation is being advocated by our Department of State. Without a serious effort to identify and review egregious screening decisions, forced repatriation means sending refugees back to persecution in Vietnam, or "refoulement." We believe that forced repatriation may start as early as January 1995 in the Philippines. Some Department of State officials have signaled to countries in the region that the United States supports this move.

To prevent such a possibility, we urge you to write to Mr. Warren Christopher and advise the Department of State not to support forced repatriation. A letter from you to the Philippine Government might help dispell their false impression of US support.

The above actions will help delay the prospect of "refoulement" but does not resolve the problem of unfair screening. We call on you, as Chairman of the new Committee on International Relations, to hold a Congressional hearing on the issues of flawed screening, forced repatriation, and the need for US leadership in resolving the crisis. We also believe that a Congressional delegation to the region will be valuable. The delegation can make first-hand assessment of the situation and come back with practical recommendations for a fair, just and humane solution.

We look forward to hearing from you.
