### Colombian rebels release American after 11 months

BOGOTA, Colombia — An American scientist held captive for 11 months by leftist guerrillas has been freed, apparently without any ransom being paid.

Tremas Hargrove, 51, of Rotan, Tens colled into his house in the some colled into his house in the some ching shis family's surprise, said a possessional for his company, the international Center for Tropical Agriculture in Cali.

Hargrove, who was abducted Sept. 23, was released this weekend in a remote area and walked and hitched rides for two days to get home. It was not immediately known why rebels decided to release him.



COUNTERPARTS LIT: Gen. Colin Powell's MY AMERICAN JOURNEY sells very well, with initial press run of 950,000 copies followed by second run of 200,000 in second sales week. Powell served enetour as Nghia Quan /PF Co Van; second w/Americal. Members invited to send in review. Some intriguing excerpts: In 1973, Powell was assigned command of 1st Bn(32nd Inf Div.) in Korea; in more ways than one, the putfit had gone to pet, and had been partially shanghaied by a core of malcontents and trouble makers. One, a Private(!) Odom greeted the arriving Powell thusly:

'I'm really delighted to be here so I can help you out. I think we'll get along fine.

Pawell: 'Oh, we're going to get along fine, you little squirrel ass, because you're leaving tenight. New get out of my office.'

Ah, the beauty of blunt simplicity. Another excerpt:

\*We seem to have lost our sense of shame as a society. Nothing seems to embarass us; nothing shocks us anymere. A sense of shame is not a bad meral compass. I remember how easy it was for my mother to snap me back into line with a simple rebuke: 'I'm ashamed of you. You embarassed the family.' I would have preferred a beating to those words."

SHADOW WAR: THE CIA'S SECRET WAR IN LAOS, by Kenneth Conboy/James Fortises. \$49.95, plus \$4.50 shipping, from Paladia Press; Box 1307; Boulder, Colorado; 80306. Member Frank Brown writes detailed, and highly favorable review in December '95 issue of Soldier of Fortune magazine. SHADOW does not limit itself to Laotian/Pathet Lao/Hmong/NVA matters, but also discusses matters such as Opn 'Leaping Lena', involving insertion of QLVNCH PROB/RVN SF personnel into Laos, and late 1967 switch from intel collection to 'bang and burn'. Authors researched subject for 10 years, conducting over 600 personal interviews, and combing historical documents. Expensive, but sounds like a good one.

BIG STORY/Peter Braestrup reprinted by Presidic Press, available from Marine Corps Assn. for \$16.95 @ 1-800-336-0291. THE definitive study. theroughly documented and researched, of journalistic malpractice before, during, and after the Tet Man Than('68) Offensive (actually, by design, and in view of overall situation, a counter-offensive). Braestrup proves that journalist is not a synonym for idiot, and with admirable precision, compares press 'coverage' with actual events, contrasting 'news' with reality. Braestrup does not have an ideological ax tegrind, and is simply after that elusive matter that so many other 'Journalists' claim to have found: battlefield realities, factors creating these realities, and consequences of both. Should be required reading for any non-veteran who wishes to comprehend what occured in VN. Braestrup's implicit conclusion: 'news' may not what it seems to be, and far too many reporters simply did not know what they were talking about. Buy copy for local library, or high school library, if none avaible to general public. Get copy for yourself if you want ammunition to support statement that news is to reality as old wives! is to quantum physics. Braestrup does not state or imply that everything was just fine in VN; he does verify what many suspect: there was an abundance of ignorant 'journalists in VN'.

COUNTERPART LIT(cont.)... Ly Tong Ba, former TL/CG of 23rd Div., and periodic counterpart of John Paul Vann, is now in US and has written a book, the title of which is unk. at this writing. Copy will be received by next SITREP, w/brief review and info on availability. In tieng Viet/Viet Namese. Like many other books w/VN authors, this should be translated into English for consumption by US readers. More info next SITREP.

PERIODICALS: Subscribers to Forbes magazine receive a quarterly publication titled 'FYI'. Very recent issue has article by member Peter Scott, titled 'Finding the Colonel', describing Pete's locating and meeting with an old comrade in arms, LTC Tanh Quyen, and the discussions they held when Pete arrived at Quyen's San Francisco apt. Very good piece of writing, w/photos. If you know a Forbes subscriber, bribe/twist arm/threaten/beg for copy of 'FYI' to read this thoughtful and welcome article.

Glad to have you all on board, and thanks for signing on.

At this juncture, it is appropriate to to provide newer members with brief outline of the assn.'s history. In 1987, responding to an inquiry as to existence of any advisor/counterpart association, Paul Brubaker, finding none, suggested one be started. A core of perhaps 20 people was formed, never having met face to face, communicating by mail, phone and voice cassette. Progress was slow and tedious, funded by personal contributions and efforts. Membership ranks grew slowly, as publicity efforts were shortchanged by time consumed in drafting bylaws, formulation of general mission statement, etc. 1990 marked the inaugural reunion, held in San Jose. There was much discussion on what we were to be, and why. Merely an assemblage of US Army Advisors? All military Advisors? Including Counterparts? Civilians? After considerable discussion, during which time the assn. carried the name Co Van Mỹ (American advisor, in VN), it was collectively decided that the entire range of counterpart history and experience would define the group, meaning anyone who served in any counterpart role, as part of his/her assigned duties, was eligible for full membership. The reason is simple: all advisory efforts were integral components of an overall program to enable the people of VN and Laos and Cambodia to stand on their own, while confronted with debilitating effects of a bloody war. Further, in view of the fact that many advisors ended up learning as much as they 'advised', and developed strong bonds of friendship and respect for their SE Asian friends and counterparts, it was acknowledged that host and guest country counterparts be accepted on an equal membership basis.

We needed a name which would immediately convey this element of our group 'personality'. 'Cô Vấn Mỹ' was catchy, but could lead some to conclude we were something other than what we intended. This was shown to be true after we began receiving mail from a number of self-appointed para-military groups, some of which had decidedly bizarre agendas, and some of which could be called 'hate groups'. Further, we needed something that might catch the eyes of, and appeal to SE Asian allies. Using the highly sophisticated technique of asking, our VN contingent suggested tagging 'Tudong Hữu Đông Nam A' w/'Counter-Parts'. Đông Nam A means SE Asia. Tương Hữu means even more than comrades in arms, friends, etc., and denotes something akin to case-hardened, battle-tested mutual trust and belief in a common cause. A tương Hữu buddy would never leave a friend when things get tough, and is manifested by a statement from a Montagnard to his US counterpart: 'You die, I die.' Was it always this way, everywhere? No. Yet it was that way often enough, and it was what we aspired to.

We had a new name.

Foundation in place, we have since zig-zagged along. Few of those in HQ were retired, and occupational/familial demands on time hampered efforts to become more administratively proficient. Worse, some in HQ took some domestic and/or occupational hits that seemed to have been ordained by mobert McNamara. We have traversed this mire, and seem better positioned than ever to foster and manage association growth, while adding to our list of good deeds: sponsoring a VN orphan under the auspices of Pearl Buck Assn.; donating \$ to worthy causes, advocating the cause of human rights in VN, Laos and Cambodia, and attempting to advance the cause of historical integrity regarding Hanoi's war against 3½ countries in SE Asia(they were fooling around in NE Thailand too). We have much more to do, much more to improve on, but we've gotten this far, have reunited dozens of lost friends, including some who'd either 'heard' or assumed a former counterpart was KIA, and have had some extremely enjoyable times at reunions.

Many ideas remain on the drawing board. Scholarships for counterparts dependents. Assn. group tour to VN, or Laos, or Cambodia. Setting up a chapter in SE Asia, or at least a contact point. Compiling an oral history, interviewing former counterparts, and telling our side of the story, which contrasts sharply with perceptions of the public at large. With continually growing membership(in spite of not having a PIO until Mike Moberts came on board), a beefed up admin section, some of these ideas are within reach. Members are encouraged to dream up more. Send 'em in; we'll put it in SITREP.

That, briefly, is how we came about, and how we got to whereever we are. Time to pour coal on the fire and make it even better. Everyone deserves a pat on the back. Many members send in material, donations, articles, etc.; many have actively recruited, organized reunions, and contributed in dozens of other ways. Hats off to all of us, for what we did then, for what we are doing now.

# Help Wanted in Reissuing DFC to Viet Pilot

I request your assistance in helping me secure a date or names of people who have knowledge about the following incident;

Major Do Dang NgHia,
South Vietnamese Air Force,
was assigned to the VNAF 114
Sq., 62nd Wing at Nha Trang
Air Base, South Vietnam in late
1968 or 1969. He executed a
heroic rescue of one of our pilots
who was shot down
approximately 10 miles north of

Phan Thiet. While under enemy fire, he landed his O-1 aircraft, jumped from the plane, got the USAF pilot aboard and exited the hostile area.

For this daring rescue he was awarded the Distinguished Flying Cross (DFC) by the United States Air Force.

Unfortunately, after the fall of South Vietnam, he destroyed every shred of evidence that connected him with the USAF. Needless to say, this saved his life but he was still forced to attend an extensive "re-education camp". He has now emigrated to the United States and has asked for

my assistance in securing a duplicate copy of the DFC.

I plan to visit the Historical Research Agency at Maxwell AFB to see if I can find any documentation, but it will take many days unless I can secure an approximate date or the names of U.S. military personnel who remember the incident.

# MINUTES COUNTERPARTS BUSINESS MEETING 5 August 1995

The meeting was called to order by Grant McClure at 0855 on 5 August, 1995. Quorum was not present for voting, but enough members were present to attend to committee business (see attachment 1, Sign In Roster).

The meeting was then turned over to J. C. Fischer, Acting Adjutant.

An up-date on business activities was presented. Chuck Thurmond, XO, has been running the everyday business of the association because no commander had been elected at the last reunion. J. C. Fischer has been the Acting Adjutant. Grant McClure was acting in the capacity as liaison in Washington, D.C. Chuck Thurmon has aquired the association funds from the past Adjutant, Steve Herberth, and opened an account at the Bank of Clayton, account # 02-16-879, which requires two signatures, to pay for association debits. (see attachment 2, Counterparts Emergency Fund, dated 7/26/95, from Charles Thurmond).

Ben Myers, Membership Chairman reported that at the last reunion we had 347 members and that we now have 422 members. Prior to this reunion, Ben mailed out over six hundred (600) reunion notices in the local area. Ben suggested that each member recruit other advisors they know in their area, he would provide the recruiting packets. His Membership Finance Report is Attachment 3. An audit was completed and approved of these funds.

- J. C. Fischer, Acting Adjutant submitted his audited Expense report for the SITREP and the Expense Report for Non-Profit Status (Attachment 4, 3 pages). SITREP is printed by Bui Quang Lam in Phoenix, AZ (at no cost to the association) and mailed to Temple, TX by Bill Laurie, SITREP Editor. Labels are printed by Ben Myers (Membership) and sent to Temple, TX. J. C. Fischer assembles, labels, stamps and mails the SITREPS from Temple, TX. The reason for this is that the Postal Permit is issued from the Temple, TX post office and postal requirements require that the mailings take place at the issuing post office. Prior to receiving the Bulk Rate Permit, it cost the association \$394.00 to mail the SITREP (429 mailings). After receipt of the Bulk Rate Permit, the cost was \$90.40 for the same amount of mailings. The Application Fee was a one time fee of \$85.00 and the Permit fee was \$85.00, which will reoccur each year. After all costs, we still saved \$75.60 in one SITREP mailing, so the permit has paid for its self. The SITREP fund has a balance of \$503.67 and the Non Profit Fund has a balance of \$230.00. Both funds were audited and are attached with attachment 4.
- J. C. Fischer, Locator/Historian submitted the Locator/Historian Reports and the audited Expense for both services. J. C. has been reunited with his former Counterpart. In all, 10 searches were completed this year and when possible, the stories will appear in the SITREP. One method of searching is done by Ben Myers by culling names from his U. S. phone book and J. C. "shot guns" search letters to each name. This is a very expensive

method with a few results. Laura Harris of Red Max Locator Service (a new associate member) is helping J.C. (Laura Harris has accepted the task to become the Locator for Counterparts.)

J. C. has completed a 166 page Roster of Known Advisors, about 7000 names. The roster includes the duty assignment and dates of service (when known) and will be available to members for the cost of printing, handling and postage. If it is requested on a diskette, send 2 diskettes (3.5 inch) and pay postage and handling. Please do not release to the public. The Order of Battle of Advisory Teams has been compiled from many sources, one being the Nationial Archives. This is also available under the same conditions.

Mike McMunn, Members in Memorium Chair stated that he still needs to work on this listing and needs the help of the membership. It now contains 605 names and he wishes to add the units as they become known. He encourages members to send in the names that they know of who were Killed In Action. He has a form he will send to anyone requesting it.

A discussion was entered into by one auditor who noted that J. C. was using his personnal funds for the Locator/Historian expenses and that J. C. was still \$89.00 in the red for out of pocket expenses. J. C. stated that Chuck Thurmond had the receipts and would refund the money.

A discussion was entered into about who owes dues and how much. At present, the past Adjutant, Steve Herberth, has those records, which it is hoped will be turned over to the new Adjutant ASAP. An increase in dues was discussed but it was noted that it would require a Constitution/by-Laws Ammendment to change the dues. Members were encouraged to make donations if they cared to give more.

The Billing Cycle is every year at TET. It was suggested that the SITREP reflect this on each TET with a symbol on the mailing address, or with a SASE envelope enclosed or a tear-off notice. Life Membership fee is \$120.00.

Positions to be filled this year: Commander and Adjutant. A plea was made, using some comments from Chuck Thurmond's letter (attachment 6). After some discussion and even a suggestion to seek a Commander for only one year, no one would step forward nor were any recommendations made. It was decided to wait till next year reunion and ask Chuck Thurmond to remain in control till then. J. C. Fischer volunteered to become Adjutant because the position was vacant. No one else offered. Dick Williamson moved to accept J. C.. It was seconded by Roy Russell. David Marion moved to cease nominations, seconded by Bob Cunningham and passed by the members present. J. C. Fischer was accepted by the members present to fill the position of Adjutant.

It was requested by J. C. Fischer that some members volunteer to assist the small office staff (Chuck and J.C.). The following members volunteered to assist:

### **ACTING ADJUTANTS REPORT**

Two Account reports are attached. Expenses for the SITREP and Non Profit mailin permit status

I began the application for the Association to acquire a Non Profit permit from the Postal Service to reduce our mailing costs. The status of this permit is still pending at this time.

The reason for this application is to reduce expenses on the mailing of the SITREP, our quarterly newsletter.

In June, I mailed 429 SITREPs at a cost of .92 each for a total of \$394.68. When I submitted our application on July 3rd, we were permitted to use a Bulk Rate permit until we are either approved or not for the Non Profit permit. The difference being, at regular rates we pay .32 an ounce, while at a Bulk Rate we pay .226 per 3 ounces and at Non Profit we will pay .120 per 3 ounces.

On July 21st, I mailed 400 SITREPs at a cost of \$90.40, using the Bulk Rate permit. Our savings was \$277.60. The permit cost is \$85.00 yearly and there was a one time processing charge of \$85.00, a total of \$170.00. The hand stamps cost us an additional \$32.00. After all costs, our savings are still \$75.60 on one SITREP mailing.
