

Post-Ballot Sitrep June 1988

Charter Members:

Yes, sitrep is late, in part due to somewhat slower response than anticipated, and in part due to time constraints on this end. This sitrep is prelim summary though does clearly point at direction we are headed. Several more ballots are known to be coming in, and reminder notices will be sent to those not returning a ballot. Once a month has passed after these notices, final ballots will be tabulated and results will be it. Subsequent changes, adaptions, additions will be via membership vote.

Still pathfinding in a manner of speaking. Two obstacles of sorts: less than half of 80 ballot respondents sent in completed ballot, and insufficient officer nominations. One nominee for President has not yet returned ballot; the other cannot serve at this time. These offices have no nominations: Treasurer, Archivist, Locator(nominee has not yet returned ballot), and Membership representation for all branches. Role as clerk-typist pro-tem has accorded yours truly with undue influence and several nominations for President. Will have to respectfully decline as my schedule is murder and could not put time in that is required during formative period. Further, I can only claim A-I membership and it is far more appropriate for a Full member to assume this position. Will continue on with grunt work so long as it is of benefit to the association.

Absence of presidential nominations raises prospects of repeated delays and mailings until this is sorted out, all of which is adverse to getting this show on the road. Will therefore submit that present operational mode be that of newsletter, pending full slate of nominees. Two self-nominations for editor will be contacted to see how this will work. Both self-nominees have word processors, and are accomplished writers.

No submitted funds have been deposited, pending resolution of officer nominations. The \$12.00/annum dues, with \$5.00 initiation fee, was approved by overwhelming majority. If editors-to-be are willing to assume pro-tem editorship, in conjunction with handling newsletter and membership funds, we can move out. If not, another means will be found, and we can move out.

Very good comments/ideas/suggestions continue to come in. One of which partains to a distinct need for a permanent mailing address/P.O. Box. Perhaps someone who knows they will not be moving could volunteer to

serve as an APO???? This is important, and would facilitate placement of publicity releases as well as handling of incoming mail and distribution to appropriate officers. Again, pending resolution of this question, will serve as mail drop for time being. There is a distinct possibility of my moving within the next year or two however, so it would be best to establish a permanent mail drop.

Comments/critiques contained in ballot response(sampling):

- faulty if not inappropriate strategy, tactical doctrine...!

 Sentiment expressed that this was someone of a cop-out, and contradicts success many advisors attained. Will plead semantical slip on this one, and intent to underscore fact that advisors often had to deal with policy from above which was not the best, yet succeeded in spite of institutionalized dumbness. Implicit assertion that decision mkers should have listened more to, rather than, inadvertantly or explicitly, dictated to, advisors. Advisors knew more about on-the-scene situations and lessons to be learned and applied; too often they were ignored. No intention to suggest that advisors were cause of these problems, but rather to suggest they were capable of rising above them, and very often did.
- ---Paragraph I-C(Purpose), referencing last sentence with phrase that 'members offer no apologies....': In final analysis, a major apology is due our host country counterparts for failure of our policy makers to do their job, as too often they did not, and US public perceived situation to be inherently worthless as opposed to hampered by poor high level awareness and action. Once again, semantical interpretation which was as unintended as it is evident, now. Yes, we do as a nation owe some apology to victims of our failing to assemble and implement a truly comprehensive strategic approach.

There were others, but these two resulted in most embarassing unintended interpretations. Am quite sure others had criticisms which may not have been expressed; all can be ironed out as progress is made. Most important of all is almost-achieved task establishing critical mass and functioning as organization with coherent purpose; getting lay of the land will be awkward at first, but increasingly doable following organizational 'recont.

Highlight summary of voting:

- Membership: '77% Affirmative vote for Full membership to military and civilian advisors, as well as host country counterparts. Periodic snide comments submitted regarding CIA people and their possible membership. No CIA people have yet applied, and sentiment is understood, with this clerk-typist having encountered some singularly drippy CIA people in SE Asia, along with a good one here and there.
- A-1 Voting Rights: 43% said full voting rights, 30% said half, and 27% said none. No majority; to be resolved.
- A-1 Membership Limits: 74% voted for no limits on A-1 members; 26% voted for 50% of Full Membership.

- A-2 Membership Limits: 69% said limit to 1/3 Full Membership; 29% disagreed, with specifications of 1/2 and 2/3 suggested as limiting numbers.
- A-2 Eligibility for Office: 82% said no office may be held.
- A-3 Nembership: 86% voted for accepting A-3 members, with 81% affirming proposed limitation of 1/4 of Full Members, no vote, no office.
- Honorary "embership: Overwhelming approval, with suggestion that 'reach' be limited to no more than 1st cousin, and that dues be 1/2 of regular membership.
- Annual Dues: 96% affirmed suggested \$12.00/year; apparent 100% acceptance of \$5.00 initiation fee.
- Patch/Lapel Pin Surcharge: 95% affirmed extra, to-be-determined charge for this option. Suggestions on or connections with vendors anyone?
- Lifetime Membership: 95% approval of \$120.00, one suggestion for \$200.00 with no raise, one suggestion that Life Membership finds be placed in interest bearing account, one suggestion that Life Membership be payable on quarterly installments(good idea).
- Officer Qualifications/Terms/Etc.: Little in the way of disagreement here, although suggestions submitted limiting officer terms to two, addit by three members, on annual basis, of Treasurer books, and combination of Archivist add Historian roles into one position.
- Regional Officers: Basically approved as written, though suggestions that local officers by locally elected, which makes great deal of sense. Also, such State(presumbaly regional as well) officers as are elected/appointed should serve on overall board of directors, receive lifetime membership upon completing three terms in office.

Resolutions:

Liason Officer for possible joint US/VN Vet Assn: Approved.

Probable Unconstitutional restriction on would-be authors:
Approved.

Mongoose/Badger stationery logo: Approved, with suggestion for something more appropriate to advisory effort, such as MAOV emblem, US/SVN flags.

Name: 65% Co Van My; 26% Counterparts; 4% Co Van My/ Counterparts(combining both). Anyone have problems with last suggestion, which incorporates good points of both, with detracting, perhaps, from either? Locator: 96% approval

Adoption of charity for encouraging voluntary donations by members: 75% approval, with following recommendations:

-Degas(Yard Assn.)

-Salvation Army

-POW/MIA

-VN/American scholarship

-any Veteran aid/assistance group

-Covenant House

-VN Women's Memorial

-any National Charity

-American Cancer Association

-SE Asian refugees

Obviously, no clear and distinct answer here, and with this being a voluntary, non-binding resolution to begin with, is probably best left open to individuals who should feel free to advise others of suggestions or worthly recipients. Good idea, but needs to be firmed up.

Dega Association Membership: 96% approval.

That s the basic drift, with final vote to be tabulated once several other ballots yet to come, as promised by these prospective charter members.

We'll probably pick up non-respondents(of ballot) in follow up mailing, and have more names coming in, so look for a charter membership of approximately 50 people. Virtually all ballots were returned by those qualifying for Full membership, with balance being probable A-ls. One A-3, a SE Asian refugee, now US citizen, who well remembers US Co Vans who served with his father.

This would be a good way for lessons/experiences to be made known to the membership. Will be interesting to compare province/area conditions, situations over time, as situation changed greatly in 1970-1974 time period(clerk-typist opinion).

I was a U.S. infantry officer and spent my tour in Vietnam as an advisor to the South Vietnamese. Perhaps I am over-sensitive to the word "defeat." The current Vietnamese Premier. Pham Van Dong, was quoted in the article saying "Yes, we defeated the United States."

I observed a different story. We worked with proud troops and people who were willing to take the often-fatal risk to get a chance at a democracy. These were not crooked politicians in Saigon, but men and women in the fight, in the country, encouraged by the concept of freedom as they

had never known It.

We fought hard. We were not defeated by the North Vietnamese. We were beaten by the inside out. We were betrayed by politicians, both U.S. and South Vietnamese, by U.S. civilian government officials using Vietnam for the big career move, and by some U.S. military brass who were using the war for their career advancement. Of course the media, then and now, made hype and sold papers by missing the point.

Yes, I am still personally frustrated after all these years. My family does not understand my part in the war, nor do my

business partners or anyone else who did not fight and live with the South Vietnatimese. I am not looking for self-gratification. I am one of the lucky Vietnam veterans who has become a successful businessman. I am not sure what I am looking for, but I do know I cannot accept journalists throwing around the word defeat with callous disregard for the facts.

Amnesty International reports that Nguyen Huu Giao, a South Viet Namese attorney, has been held in prison, since 1977, for publicky: reading a Human Rights Declaration on the steps of the Saigon Nha Tho Duc Ba Cathedral. They request that letters requesting his release be sent to:

Truong Chinh Cha**ir**man of the State Council Hoi Dan Nha Nuoc Ha Noi Soclalist Republic of Viet Nam.

Such letters may well be ignored, but worth a try.
