* "Re-education — North and South," by Ginetta Sagan (Exec. Director, Aurora Foundation), eb. 6, 1988. Preliminary draft of a paper detailing grim conditions in the re-education camps in Vietnam, to be published this spring in a report on human rights violations in Vietnam since 1975, by the Aurora Foundation, 177 Toyon Road, Atherton, CA 94025.

"Letter From Danang," by Donald Kirk (USA Today) in FEER Nov. 17. Foreign war correspondent Kirk revisits Central Vietnam which he knew well in the Vietnam War days. In Danang he finds the Third U.S. Marine Headquarters is now the Nguyên Ai Quốc Academy and that the former U.S. Consulate has become a "war atrocities" museum where daily the film "Platoon" is screened for visitors. In Hue he reminisces with ex-Viet Cong and PAVN officers who are now assigned to draw up programs to attract foreign visitors.

Second publication: Human Rights Violations (political, economic, religious, etc.) Viet Nam 1987 (not knownif still available or if superseded by newer edition). Cost unk. Put out by Viet Nam Committee on Human Rights; 25 rue Jaffeux; 92330 Gennevilliers; Franch (Tel-Paris: 47.93.10.81. They're active in camaigns on behalf of boat people, political prisoners, rights of organized labor. No info on publication frequency or whether they restrict themselves to one-time-only editions on specific matters/developments. Material Jim sent provides detailed info on control measures used to smother dissent in VN. Nice place. Accompanying letter said 'The 500 dong note brought back memories, but the Ruby Queen spot put a smile on my face. I could almost see the pink color of the pack. The purple pack of Bastos were cheaper and my counterpart smoked and so I smoked them too. I lived the Spartan lifestyle of the Junkmen (coastal junk fleet for which Jim was an advisor), ate the same meals, and actually loved it-must be a little crazy to those who don't understand.

Thanks to Jim for this info and letter.

Another member sent a summary of efforts to locate former counterpart, still believed to be in VN. Names deleted per writer's request, but procedure was initiated by writing congressman, requesting help from US govt. Neither Dept. of Army nor State Dept. were able to do anything, though StateDep suggested sending letter to VN Permanent Mission to UN(at 20 Waterside Plaza, Apt. 293; NY, NY; 10010). Decision was made to cease all formal attempts at this point, with all indications being that such inquiries might cause harm/herassment to former counterpart. It's going to be virtually impossible to safely contact anyone in-country, and there is little hope other than info networks among veterans community, and this one in particular.

Another member received first hand knowledge, from someone that has since left VN, that a former mutual friend emerged from reeducation camps as a broken man of marginal sanity. Fate/whereabouts not presently known.

Recent news'item: As of 14 March, 1989, all six members of ASEAN will refuse to accept anymore refugees for third country resettlement. No indication whether this means forcible ejection or holding for formal forced repatriation(as recently done in Hong Kong). See accompanying profiles of former counterparts in refugee camps(courtesy of Paul Brubaker, xeroxoplagiarized from 'The Drop'). Things are unlikely to improve.

Continuing in related matter: Amnesty International's Dec 88 'Freedom Writers' suggests letter be sent to Laotian govt. on behalf of Khamphan Pradith, former Laotian civil servant and poet, imprisoned since 1975 for his political beliefs. He is reportedly in ill health and has not seen wife/family since 1975. Send letters to----next page----

These letters can work. Death sentences for two Buddhist monks, Thich Tue Sy and Thich Tri Sieu were recently commuted(to 20 years in prison), after world public opinion brought to bear on Hanoi, via formal government protests(US, Australia, France, et al).

Here's one more: Mguyen Thi Nghia, lay member of An Quang Buddhists, is in slammer for 'counter revolutionary activities'. Hanoi dissolved An Quang in Mov 81, but is having more trouble eradicating ideas/philos-ophy/religious beliefs. Send letter to: Vo Chi Cong; Chairman of State Council; Hoi Dong Nha Nuoc; Socialist Republic of VN; cc to SRV delegation at UN(address above) would not hurt matters any.

<u>DEGA ASSOCATION</u>: last sitrep sent to Degas; no response to date. They are aware that Dega Assn. has open invite for assocation membership. Sitreps will continue to be sent.

Other Dega matters: Member Dave Berman spoke with Kay Reibold, who visited Highlands last year, stopping in at Jarai and Bahnar villages. Ms. Reibold called clerk typist asking if we'd include mention of Medical Air Project in Central Highlands, designed to bring a modicum of health care/supplies to Montagnard villages and people. Told Ms. Reibold that I could not and would not speak on behalf of members, but would put the word out, while adding that some/many would be skeptical as to whether any benefit would actually get to people for whom it was intended(with good reasons for such doubts). Ms. Reibold came across well, and project appears to be free of any subdued political agenda. Aid program is being handled by Dr. Raleigh Bailey and Pierre K'Briuh; Lutheran Family Services, Inc.; 131 Manley Avenue; Greensboro, North Carolina; 27407. Write if interested. CCNVENCION POSSIBILITIES: hue and cry for get-together is rising, and with good reason. Problem is minimzing time/distance factor for most members. *Hanoi agrees in principle to your_ proposal for the establishment of a reception center in Ho Chi Minh City."

The telex from the Vietnamese capital was read to me over the phone on September 13 by a representative of Vietnam's ambassador to the United Nations in New York City. And it represented a diplomatic breakthrough which has taken years to develop.

The Foundation's proposal to the

Vietnamese government calls for us to operale an Amerasian Reception Center in Ho Chi Minh City, formerly Saigon, site of the ongoing interview process to get Vietnamese Amerasians and their immediate family members out of Vietnam. These people have been making pilgrimages to Ho Chi Minh City ever since the departure process was resumed in October 1987 after an 18month bureaucratic stalemate between the U.S. and Vietnamese governments.

For many Amerasians, the journey to Ho Chi Minh City is one- way. They leave their homes, use whatever monetary resources they have for transportation and surrender

their ration cards when they announce their intentions to leave Vietnam. While they wait to be interviewed, to learn of the results and, hopefully, to see their names on a flight manifest, they often live in the streets, without basic services. Our proposed center would 📏 house up to 400 people at a time as they work through the departure process and would provide food, medical care, functional English language training and counseling. The Vietnamese authorities have invited a Foundation delegation to Hanoi to discuss the implementation of our proposal.

The U.S. State Department may wish to settle this issue government to government, so our proposal may not reach fruition, But we will meet the Vietnamese, get a first-hand assessment of the Amerasians' situation and do everything in our power to help the children of America who are still suffering as a result of the Vietnam war.



DEROS speech: Apologies extended for shortcomings/irregularity of Sitrep. Work eats up 50-60 hours/week, before getting into motor pool and post engineer chores, and then playing DI for a 13 year old son. Ain't easy to stay up with things. Very sincere thanks extended to all for your efforts, letters, info, etc. As a number of you have said, it's sometimes hard to find a place in vet groups whose members do not share the common experiences. God forbid you should ever say you actually liked nuoc mam; ate pho, hu tieu, xoi lap xuong, nem; drank ruou de, ruou nep than, ruou Ong Gia or nuoc rao ma(you may not remember the names); or smoked Ruby Queens, Bastos, Aras, or Capstans. 505 mebbe? There should be some very interesting discussions and recollections at first gathering. Anyway, letters/thoughts sent in beats the hell out of watching 'China Beach'.

Spectrum of experience of members is very wide and diverse. Chau Doc in '66 cannot be compared with Tay Winh in '68 or Pleiku in '72. Some members worked with thoroughly competent counterparts, and some did not, and we'll no doubt here some interesting stories from host country counterparts in the future. Yours truly encountered a couple of would-be advisors of such

questionable character and competence that I would not let my pigs(if I had any) eat their garbage. All too overlooked however(except by many members of this assn.), is that many were, and are, impressed with the people with whom they served, while acknowledging very real problems existing elsewhere. In any case, it's all part of a segment of history that is typically overlooked by those



'learning' about VN via movies, TV and a number of rather stupid books.

Interesting evaluation by US advisor who accompanied ARVN lst Div. elements on mission to knock out NVA rocket positions: "I was totally impressed and dazzled by the way they operated and by their daring in doing things....This was the thirteenth operation like this that this guy (the ARVN Bn. XO) had led. You're talking about people that are total experts at what they're doing, who have done so many hair-raising things already and are still doing it. I was blown away by this whole operation." Operation in question involved instant reaction to hard intel, night march(no airlift, no arty prep), and pre-dawn assault on NVA position. Advisors and counterparts can best explain why some units evolved so well, while others did not. (Quote is of statement by Richard Stevens(four years in VN), from unpublished master's thesis by Howard Feng, University of Hawaii, 1987).




Healing and Reconciliation Retreat for VN Vets, conducted by Thich Mhat Hanh, 9-14 April, \$250.00 w/meals/lodging. Thich(Venerable) Nhat Hanh is a Buddhist monk, poet and teacher.
