My year with the ARVN by Robert D. Parrish

当时的证据检查程序 T. Robert Parrish didn't want to be an advisor to the Army of the ... Republic of Viet Nam; he'd heard things about them. The Army didn't care what he wanted; he was assigned to the 5th ARVN Division, an infantry me battalion. A year later, Parrish knew he'd fought at their side, and wouldn't have had things any other way. Contrary to rumor, the ARVN were an aggressive, tenaclous outfit. He and his 🔏 men averaged contact with the Viet Cong two to three times a week. Usually it meant a fierce firefight, but the "contact" could take more bizarre forms. Fumbling his way through an uniamillar Buddhist ceremony in a monastery, Parrish noticed : some others in attendance were as :: ignorant of the ritual as he was. He later discovered they were VC, His Vietnamese commander, when asked why he hadn't found the other "worshipers" suspicious, replied, "I'm a Catholic."

This man will not quit or give in; those of us blessed to be on the outside have no excuse for inaction. This wretched situation is entirely overlooked by many who want to schmooze up to Ha Noi.

HISTORICAL OBJECTIVITY DEPT. Michael Janeway, Dean of the Medill School of Journalism, Notre Dame, wrote recent article for New York Times Review of Books in which he indicates 'truth' of Viet Nam was concealed until 'courageous reporters like David Halberstam and Neil Sheehan ... Morley Safer, Frances Fitzgerald, Harrison Salisbury ... and Gloria Emerson' revealed it. Oh? In another publication, David Cortright, of Notre Dame's Institute for International Peace Studies, lauds the merits of Sheehan's BRIGHT SHINING LIE, a book of questionable integrity, saying it 'greatly expands our understanding of the Viet Nam tragedy.' Sam Houston State) and Randy Roberts, history professor, Purdue, come to some 'politicly correct' conclusions. Young asserts 'war continues to be primary instrument of American foreign policy (Dear Ms. Young: Hanoi started the war.... US went to absurd lengths to negotiate out of it...) while Olsen/Roberts cite books MY LAI(Seymour Hersh), BRIGHT SHINING LIE(Sheehan), Karnow's VIET NAM: A HISTORY, are singled out for praise. Again, note positions/spheres of influence authors have. Historical inquiry appears to have degenerated into intellectual gossip, with each layer of mental fungus generating and feeding yet another. Mike Little, our diligent Dega Liason Officer, sent update indicating photos documenting receipt of medical supplies at Ea Ana leprosarium have been received, finally. Also, \$10,000.00 grant received from Mary Lynn Richardson Fund; medical supplies and diesel generator, accompanied by Lutheran Family Services delegation, scheduled for April 91 delivery to Ea Ana, near Pleiku. ## **ECHOES FROM ANOTHER WAR**

About 15,000 Amerasian children and their families will be allowed to resettle in the U.S. in 1991, a Vietnamese Foreign Ministry official said.  $\sqrt{31/9}$ 

The agreement came after four days of meetings in Hanoi between teams of U.S. and Vietnamese experts, said Le Bang, deputy chief of the American department of the Foreign Ministry. He sald 18,000 former employees of the U.S.backed South Vietnamese government and their families would also be resettled in the U.S. this year in accordance with agreements between the two countries.

Since the resettlement program began In September 1986, more than 30,000 of about 50,000 Amerasians, the children of Americans who served during the Vietnam War, have gone to the U.S. About 13,000 former members of the Saigon government and their families have been resettled since September 1989.

Mr. Bang sald the two countries hoped to complete the resettlement program by

the end of 1992.

POW/MIA: Ha Noi Foreign Minister Nguyen Co Thach, meeting with John Vessey in D.C. raised possibility of opening POW/MIA liason office in Hanoi; US first proposed in '86. Proof of pudding is in the taste; we shall see. Also, some response to last issue's questioning veracity of book, KISS THE BOYS GOODBYE. J.C. Fischer sent in copy of report prepared by Sen. Helm's staff, which concluded high probability

of POWs in VN/SE Asia, and asserting US govt. efforts have been less than forthright/competent. For your copy: 'Interim Report on the Southeast Asian POW/MIA Issue', write: Senator Jesse Helms United States Senate, Committee on roreign Relations, Washington/D.C., 20510-6225. Central point in this discussion isn't a debate as to whether POWs are held or not, but rather reliability of book mentioned. Clerk-typist will plead ignorance in not yet having read book, but will assert that one of book's sources, Scott Barnes, is borderline pathological liar. Christic Institute, another source, not far removed. Still, even a broken clock tells right time, twice a day, and all of us need to weigh this material on its own merits. Info must be hard, not conjectural. Please remember to consider intent in disagreeing on this or other issues. All want full resolution of POW/MIA issue. Intensity of commitment can lead to agravation/antagonism when different avenues of approach are deemed best. Whatever your individual position/views on nature of situation, and appropriate means to resolve same, make them known via letters to Senators, Representatives, newspapers, US State Dept., Ha Noi delegate to UN, etc.

COUNTERPARTS BIBLIOGRAPHY: interim progress report to be included in next edition. End product available to members for expense equal to photocopy/mailing cost. Get one for yourself, one to give out to any educators, writers, etc. you may come across with interest in the subject. Sooner or later you'll hear 'I've never heard that before. CONDOLENCES: To family and friends of Viet Namese publisher Nguyen Kim Bang, who immolated himself in protest of communist rule in Viet Nam. Bang had served in the QLVNCH(SVM military); his grandfather, father, uncle and younger brother were all killed in the war. Since arriving in US, he began his publishing career and persistent efforts to shed light on human rights violations in VN, and plight of the Boat People. His death was briefly noted, on either pages 5 or 13 of US newspapers, if at all, underscoring a still unpleasant situation: most US people simply don't care, nor does US news media which-let's face it-had such a ball with front page photos of Buddhist immolations in 1963.

And...Don Colin, who spent many years in Viet Nam as StateDept. Prov. Rep. and Buddha/God knows what else, passed away of heart attack, age 55. Don wore sandals, smoked Ruby Queens, and was an iconoclastic free spirit sorely needed. He was active in Amerasian matters, and unswerving advocate for human rights in Viet Nam. If things had turned out differently, Don might yet be living on his wife's small farm in Tra Vinh(AKA Vinh Binh), playing co tdong, drinking ruou de, and laughing uproarously at ribald jokes with local friends in the countryside. Like many, Don was probably more at home enjoying life's simple delicaciesin Viet Nam, than he was in modern day US. Take it easy Don, we'll hoist a glass of nuoc mat que huong to you, hoping they sell Ruby Queens in your current AO.

HONG KONG UPDATE Last two editions cited hardline attitude of Hong Kong authorities in refusing to classify Boat People as real refugees, downgrading them to 'economic refugees' faced with prospects of forced repatriation to Viet Nam. No apparent change in situation. Letters from refugees requesting appeal and intervention of international human rights organizations are replete with examples of an Orwellian nightmare. Forced repatriation viewed by some as equivalent to death sentence. US newspapers and mews media carry little of this.

DESERT STORM LETTERS: If you haven't written, you should, and now. Write a few, and sooner or later you'll get a very grateful response, from an appreciate serviceman/woman. You didn't join CO Van My-Viet/Dong Nam A to do nothing, so do something. Address in your local papers for 'Any Serviceman/woman', as well as recent edition of SitRep(one more reason to keep all editions in one folder or three ring binder). Speaking of which, efforts underway to work into a new format, find economical means to this end. Will check into possibility of prepunching holes for ease of filing.

CAMBODIAN COUNTERPART MAKES GOOD: Sichan Siv worked for a US relief agency in Cambodia, only to be swept into vortex of Khmer Rouge madness. Surviving by his wits, and escaping into Thailand, Siv finally made it to use, worked menial jobs, scrimped/saved, went Columbia University, later picked up a master's degree later working at the U.N., thence to Institute of International Education, campaigning for George Bush. On 13 Feb 89, Sichan Siv was sworn in as daputy assistant to the President, as liason to public interest groups.

SON OF COUNTERPARTS MAKES GOOD: 'Saigon' Skipper Kelp was born in-where else?-Saigon about 20 years ago, coming to the US w/his US Army Sgt. Father and Viet Namese mother, now residing in Colorado Springs. Fight was a donnybrook(a clean one). Boxing fans take note.
