Letter on following page sent by former RVNAF personnel pictured above. In addition, a number of former counterparts have written from this refugee camp-Sungai Besi, Malaysia. Their situation parallels that of former counterparts in Hong Kong, Thai border camps, and other inhospitable locales. To repeat, the ol' fixeroo appears to be in. It would appear that one can only qualify for political refugee status by having planned to assassinate Ho Chi Minh himself, otherwise forget it. All members are requested to send letters to their elected officials to demand examination of current refugee qualification procedures. A number of Human Rights organizations have expressed contempt and anger at the cavalier manner in which refugee status is denied. These are our former comrades. They have no one else to turn to. Do something. Write somebody in D.C. Counterparts/THDNA elected officers have written letters, receiving little substantive response from anyone. Volume is needed. Many letters from many people.

Individual locator requests from Malaysia and Hong Kong have been forwarded to J.C., and are included in this issue's 'Locator Report'. If and when bona fides can be established via confirmation of a former counterpart, some of these veterans may be granted political refugee status. As an incidental benefit, your letter will irritate an otherwise smug, business-as-usual bureacrat somewhere.

SITREP copies sent to Malaysian refugee camp, providing them with some hope, and an awareness that someone, somewhere, is aware of their plight. Members sending letters to elected officials, UN, etc., are encouraged to send copies to Tran Thanh Liem, whose address is listed on following letter.

Dear Sirs:

First of all, we'd like to express our best greetings from the members of the Leadership of Veterans Association of The Republic of Vietnam in Sungei Besi Refugee Camp.

At the thought that you all have been on our side before, that we have fought to protect the freedom against the Communists, we're expecting your help. That's the reason of this open letter.

Presently, some of Ex-Military Servicemen, Civil Servants and US Agency Employees are not considered political refugees. For a certain political reason, couldn't return to their homeland, therefore they are living in a depression, feeling discouraged and waiting for an uncertain future.

Up to now, among those whose refugee status have been denied, there were :

- 21 Officer.
- 63 N.C.O.
- 97 E.M.
- 14 Popular Forces.
- 7 Cadres.
- 33 Civil servants
- 11 US Agency Employees.

We have sent to "COUNTERPARTS/THDNA" a letter asking for help in this matter and the organization has raised the question to The US Parliament and Foreign Affairs Department, and asked that the above-mentioned Ex-Regime Men be considered political refugees, according to the criteria of C.P.A.

We long for your strong help and we should be grateful to you if you would join "COUNTERPARTS/THDNA" and raise this issue to the higher authorities so that the unfortunate Vietnamese Boat People could be saved.

We look forward to your kindness, and now we all are waiting for your action.

Awaiting for your reply, we remain.

Counterparts/THĐNA leadership has decided to contribute \$100.00 to youth club treasury, out of our general fund. There is no mechanism, clearly stated, which empowers your HQ to commit funds without member approval, yet it was felt necessary to act promptly without a time-consuming referendum. If 50% or more of COUNTERPARTS/THĐNA membership expresses written disapproval of this decision, those responsible for same will cover it out of own pockets.

Same applies to \$100.00 donations to Viet Nam Assistance to the Handicapped(VNAH) program describe in last issue, and \$100.00 to Highland Assistance Project.

All of these programs provide direct and immediate assistance to former counterparts, through credible agencies. Again, if 50% or more of members disagree with this arbitrary decision, the \$300 will be recovered via contributions of those suggesting such actions be taken. Member opinion welcome, and will be conveyed in following SITREPs.

The situation being what it is, periodic donations can be expected as time passes. We can't do everything(yet) but it is incumbent upon us to do what we can, when we can.

COUNTERPARTS/THDNA CO Grant McClure was on hand to welcome the new arrivals in Greensboro, North Carolina, where members of the Special Forces Association have performed heroicly in meeting the tremendous logistical demands of resettling 398 Dega. The arrival was not without tragedy. Y-Cong Nie died of heart failure just after reaching US shores, and Y-Soli Siu died at his birth. Our condolences to their families and friends.

All Dega were from central provinces-Darlac, Lâm Đồng, Quảng Đức, etc., in keeping with past patterns. Little information has been forthcoming regarding northern tribes (Bru, Hre, Sedang, Halang, Facoh, etc.). Lacking political cohesion, population and leadership of central groups, northern cousins are more vulnerable to Ha Nôi's 'mission civilatrice'. Members having information are encouraged to submit same.

Member Kok Ksor, President of the Montagnard Foundation asked that his open letter to Counterparts Members be included in SITREP, and so it shall be-see next page. Our best wishes to all new arrivals.

And, with increasing size and meddling in world affairs comes the need for a PIO, i.e. public affairs officer. Anyone w/some experience also encouraged to contact Grant. This is an important position and one whose duties are beginning to exceed time available to existing HQ staff. Another looming responsibility in need of attention: ODP(Orderly Departure Program) and refugee camp information wrangler/project officer. A number of our members are working, often with great frustration, to get former counterparts out of VN to US, or sprung from refugee camps. We have no central source of info, no one to monitor progress(if any), offer suggestions, etc. Position would entail more of info-clearing house task than engaging formless blob of bureacracy, while helping members w/advice, suggestions. Think about it.

LOCATOR Bobby Jackson's letter, reminted as sent, underscores value and importance of J.C. Fischer's assiduous efforts. Chances are Chinh and Bobby would never have met again were it not for this outfit and J.C.'s diligence. Here's excerpt from another grateful 'customer':

'.. I had long desired to find the US Army advisor to the 37th ARVN Rangers at Khe Sanh, Walter Gunn. Shortly after contacting Mr. J.C. Fischer, he called back with Walter's phone number. We have since been in contact and I have been able to learn more about the 37th's constribution at Khe Sanh while I was charlain there during the Siege. Thank you all for making this possible through your organization. It is truly Miraculous that after 25 years, a quarter-century, Walter and I have reconnected. I am enclosing a donation to help your locator efforts.

Many of you have been, these many years, endeavoring to move forward with your life, allowing occasional reflection on your past, particularly your role as an advisor. Sometimes you ponder your contribution, weighing its effect, its consequence. Your thoughts often include questions about the fate of your counterparts and friends who you advised and worked with. Likely you have as often wondered about and reasonably doubted the survivability of your comrades after the fall. Like you, I have set aside such thoughts after limited reflection.

Then, just a few short months ago, I was introduced to Counterparts by a business associate who gave me an address to contact. Subsequent to my inquiry to the organization, remarkable events have unfolded. With the encouragement of J.C. Fischer as well as the generous and unselfish assistance of Bill Laurie, I was rewarded with the opportunity to become reacquainted with one of my counterparts from 25 years ago. I was initially pleased to learn that he had survived, and when I discovered more details, I was astonished that he did so under utterly appalling circumstances.

In early 1967, I served as the assistant advisor to the 37th Ranger Battalion, 1st Ranger Group out of Quang Ngai and Danang. At that time, then 1LT Chinh Van Nguyen was a company commander. He and I spent many weeks together, participating in operations throughout the southern I Corps area. It was a heavily disputed region, especially prior to the arrival of contingents from the 1st Cavalry Division and other Army units. The Ranger units were constantly engaged in operations in these areas and the small US Advisory teams lived, worked and fought with their counterparts. The advisors were proud of these Rangers and their abilities in combat. As a company commander, Chinh Van Nguyen always displayed the fearless and skillful leadership essential in the most trying of circumstances. He was then an outstanding leader and is now an exceptional person.

What a rewarding experience to become reacquainted with Chinh! To share time with him in his home. To meet his family, who he was determined to have join him in America. (Nearly seven years of separation after his escape from Viet Nam preceded by more than 10 years of separation while he was held in North Vietnamese prisons.) Equally rewarding was the opportunity to share the reunion with my son, having him be a part of such a great experience.

If you have contemplated making a move to inquire about your former counterparts, other comrades or friends, I urge you to make time to do so. Set aside any reservations or hesitations that you may have. Believe me, you will benefit by the effort and you can endow others with your fortune.





ed to his sterling performance as as Minister of Refugee Resettlement. Author Fontaine worked with Dr. Dan and knows well of his subject, an unyielding opponent of both communism and corruption, and a man dedicated to the well-being of VN people. Neither Dr. Dan, nor his family were 'sunshine patriots'. Dai Uy(Capt.) Phan Quang Tuan, Dan's second eldest son, could easily have avoided military service, with his Father's influence, had he so chosen. Capt. Tuan was KIA, his Skyraider shot down by NVA missles, over Quang Tri Prov., 6 April, 1972, after he'd knocked out seven NVA tanks. Dr. Dan's efforts continue to this day as he actively campaigns for Human Rights in his native Viet Nam and throughout Indochina. 'Our side' was not without its sins; we were less than perfect in a number of respects. Nevertheless, US ignorance of Dr. Dan, and others like him, is inexcusable and reflects the 'National Inquirer' attitude prevailing: if it's not vile and perverted, don't tell me about it. This is another book which should

The average tourist-doofus would see 'primitive' thatch huts and little more, oblivious to the intricate relationships and workings of a village society, the complexity of which rivals many computer programs. This age-old marvel is now under assault, and has been for the past 18 years, of policies designed to create a new socialist man(and woman). POW/MIA ISSUES 10 chapter, 800 pp. Select POW/MIA Committee report now available. Initial request may result in receipt of 55 pp. 'Executive Summary' so specity desire for full report in correspondence. Two separate volumes, a five section Appendix, and annex of cited documents were also published. Members having reviewed full report are invited to submit a review/critique. Just as the dust began to settle after often acrimonious charges/counter charges flung about in the hearings, another bombshell hits the scene, with discovery of supposed official Ha Noi

internal document, dated 12 Sept 72(as typed) suggesting 1,205 US POWs were held, as opposed to 368 Ha Noi claimed at that time. Document was found in Soviet Communist Party archives, and was authored by Ge. Tran Van Quang, then deputy chief of staff for Ha Noi military. Stephen Morris, Harvard researcher who found the document expressed his thoughts that this 'is the biggest hostage taking in the history of American foregin policy.' Retired General John Vessey visits Ha Noi this seek week and will no doubt discuss this matter. As expected, vehement denial issued by Ha Noi, similar to thoughts expressed at right in letter from Ha Noi's UN PR lady. Members wishing to respond to Miss Hong may reach her at address below her letter. In preceding and related matters... 16 sets of remains were US officials on 7 Aprol 93, bringing total to 532. Following established procedure, remains will be examined in Central Identification Lab facilities, Hawaii, for verficiation. Several groups of private citizens have gone to VN, accepting Ha Noi's offer to 'look for yourself'. Patricia O'Grady w/husband John Parsels, former POW, left to VN in March, destined for VN/Lao border area in search of info regarding O'Grady's father, MIA since 1967. Larry Braden of Gilbert, Arizona left shortly thereafter on a similar private sector fact-finding mission. Another group, under the auspices of the Live POW Lobby of America, did not fare well, reporting harassment, travel ienial, and various/sundry obstacles placed in their path. Negative sitrep on POW/MIA news from Laos.

Members need not be reminded of FOWs seldom discussed in conventional news media: former counterparts subjected to discriminatory policies within their own countries. We've got a way to go before this matter is resol-

ved, in all its many respects. In a related item, last SITREP stated 'Member X' may visit Sungei Besi Refugee (de facto POW) camp at member's own expense, later to provide report for COUNTERPARTS/THONA. Trip is still pending. You'll be informed if/when it takes place.

Cambodia search efforts halted as US team takes fire from Khmer Rouge. No US casualties. LTC Charles Clayton, Tm Ldr, said 48-man recovery team will return to US, suspending operations until security is guaranteed. Incident took place in NE Cambodia.

beginning.





CAMBODIAN UPDATE: All's bad that stays bad. UN contingent has not/cannot disarm Khmer Rouge, and Ha Noi-founded Hun Sen govt. in Phnom Penh refuses to disarm for this reason. Govt. forces attacked KR HQ; KR retaliate by blowing up bridges and railroads. UN Security Council formally endores May elections without KR participation.
...Khmer Rouge still very nasty. Ethnic VN living in Cambodia have been killed w/worst known instance being massacre of 34 civilians and wounding of another 29. KHmer Rouge, in supreme breach of etiquette, kill three UN Peacekeepers(Bulgarian contingent) who had invited them to dinner. KRs ate their meal first, left, returned to do their deed. Swell bunch. \$2.8 billion UN effort(\$648.0 million US-funded) not making headway. 100,00 th Cambodian refugee resettled from Thai camps back to Cambodia; remaining 250,000 planned to return on/before May '93 elections. LAOS UPDATE Pathet Lao spokesman offers incontrovertable proof that civilians are not among casualties in periodic outbreaks with resistance groups: 'Only rebels step on mines; villagers don't.' Simple as that. David Andrianoff, of Christian relief agency World Concern, was expelled from Laos for having 'subversive books, proselytizing and inciting revolution to bring back the former Lao Kingdom.' Andrianoff claims to have had religious books for his own use. Two Hmong-Americans expelled from Northern Thailand for allegedly organizing crossborder ops into Laos. 29 Lao families/109 people, return to Laos from Thailand, under UN auspices. Total returnee count as of late 1992: 1,866.

25% of Laos export earnings come from transmission of electricity to Thailand, much of it produced at Nam Ngum dam, a USAID project completed in early 1970s. ... John Porter & Tom Lantos; Ford HOB H-2-590; Washington, D.C.; 20515(land line 202 226-4040) protesting forced repatriation of Hmong refugees to Laos, without any meaningful guarantees of freedom from political oppression. Congressmen cited above plan to hold hearings on this subject, making up for complete absence of any coverage elsewhere. MEMBER PROFILE I arrived in RVN Feb '65 and was assigned to Adv Tm 1 Da Nang. While waiting interview w/Corp SA, I met Maj. Ray Battreall; he told me to forget the interview and go with his driver to 4th Cav HQ. Months later the Corps CSM told me I was supposed to be with a sub-sector. Ray had stolen me from another unit and I thank him for it. Just with the CSM hadn't screamed so much when he found me 2 months later.

My first month I learned alot about RVN Armor, which was not equipped like US Armor units. The 4th had an M-8 Armored Car Troop, an M-24 Tank Troop, and 3 Mll3 APC Troops. The M-8 and M-24 were straight out of history book photos. I was later assined to 2nd Troop in Tam Ky, staying with them until Dec 67.

I wondered what I had gotten myself into. Having served six years with one of the best US Tank Co.s in Germany, it was odd to serve with an armor unit which used APCs for tanks; no big guns. The troops spoke no English and I spoke no VN. I wanted out. They have no discipline, wore sandals, no formations, no saluting. Looked like a disorganized gang to me. Boy, did I have a lot to learn, and had to quit thinking of them as a US display unit. They were a combat trained unit, proven and tested. I was not there to teach them anything; they were teaching me how to stay alive. It only took a little time to find out they were very disciplined, well trained and organized, combat ready everyday and night. They got the job done with a lot less support then any US unit I ever heard of.

PROFILE(cont.)

I learned fast, and developed nothing but respect for their abilities. They did a much better job, with the equipment they had, than I believe an American unit would have done. A USMC Armor Bn CO visited us in Quang Ngai to see how our APCs were working out. When he left I felt sorry for Marines in his unit. All of our APCs had over 7,000 miles on them, and he believed they were new or had been overhauled. The next week his Maintenance Officer and NCO paid us a visit to pick up some pointers. That made this Advisor stand a lot taller.

The QLVNCH(ARVN) commanders cared very much for their troops; they had served with them a long time and knew them well. In addition, the commanders took on added responsibilities of maintaining welfare of their troops families.

Despite the lack of support(relative to US units), the Commanders and troops were very aggressive. If I have to go into combat today, I hope it would be with a unit as good as the VN unit I was with It was an honor to have served with them.

In Dec 67 I was reassigned to I Corps Liasen Office, Ch¢ Lén. Good food, good quarters, bad job, spending most of my time waiting for something to do. Later reassigned to Bangkol R & R Center. What a deal that was!

I eventually returned to VN, looking forward to serving with a QLVNCH (ARVN) field unit, but bad luck struck and I ended up at HQ MACV, later to Da Nang AFB as Ground Liason NCO. No more field time for me so I didn't extend again, arriving in US after 42 months in country. I retired in Oct 69, finishing with a Ft. Knox BTC.

I heard of Counterparts in 1989 and joined, finding all the members had experiences like mine. We believed in what we were doing and believe there were no better people to do it with than the Việt Namese we had the honor of working with. Counterparts is not a group of 'professional veterans'; it is group of veterans with well-deserved pride.

BLAST FROM THE PAST No incoming stories to top John Bailey's 'Great Turkey Debacle' of last issue, so your editor will provide one...
'With four months of VN language school under my belt, I arrived in country with some grasp of the language, but was still less than precise with tonal inflections, any change of which can completely change the meaning of one's speech. It was soon apparent that there was a lot more to be learned, and that full command of VN had not been attained. As the first weeks passed, I became a regular customer of a few coffee and soup stands-quan nho, and in particular one run by an aged VN woman whose son was an ARVN soldier. After a few weeks, I was a 'regular', and accordingly we comed by dear old Basis Bây as well as other regulars, all of whom helped me in my often awkward pursuit of linguistic fluency in VN.

One day, a small boy from the area stopped to look at the 'Ngddi My' and overheard my VN speech, or attempts thereat. He approached, struck up a conversation, and asked how old I was. Feeling confident with my growing vocabulary, and being a bit facetious, I responded by saying I was 'Mr. Old', a VN term for an elderly man. Immediately faces turned to me, aghast with shock; others turned away, their shaking convulsions revealing uncontrollable laughter. Ba Bây leaned against a pole, laughing so hard that she began to cough and spit out her wad of betel nut chew. It was readily apparent that incorrect tonal inflection had changed the meaning of the word I'd thought I'd used, and changed it in an uproariously funny way. The laughter subsided in a few minutes, Ba Bây said not to worry about it, but would not tell me what I'd said, which, as I was to find out shortly after, was 'I am Mr. Penis', rather than I am 'Mr. Old'. Cu means penis, and is NOT a clinical term; cu means old. After that I avoided 'cu', or made sure of applying any and all tonal inflections, and avoiding the flat toned inflection of 'Mr. Penis.' Tone marks do make a difference.
